When I was in Vail, there's a Judge Fred Winer that I met through Pepi Gramshammer. Pepi is going to be sworn in as an American citizen on September 16th and wants a letter from the President to go to the Judge, not just for Pepi, but on behalf of all of those people being sworn in that day.

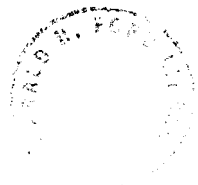
The Judge will read it at the swearing in ceremony in Denver.

The Judge's address is 220 United States Courthouse, Denver, Colorado 80202.

It should be a letter from the President to the Citizenship Class, and it should go out immediately so that he has it ~~w~~well before the 16th. Once it's mailed, you ought to call the Judge and let him know it is on the way.

In addition to that, make ~~s~~ certain that a very nice letter is written to Pepi from the President that he signs himself, that's suitable for recognizing his willingness to become a United States citizen on Sept. 16th.
