Attached is the proposed schedule for next Thursday's trip. I have instructed the Advance Office to plan on using the Camelback Inn facility in Phoenix (p. 2).

At Tab B you will find the proposed personnel breakdown for the trip. You may not want to invite the entire Congressional delegation because of your plan to spend a good deal of time with Congressman Rhodes on the flight back from Phoenix. In addition, Ron Nessen has indicated we plan to have Helen Thomas of UPI on board the aircraft for a one hour interview, previously scheduled for Camp David, November 9th.

I would recommend that both Dean Burch and Jack Marsh be invited to make the trip. Dean is from Arizona and this will probably be his last opportunity to travel on Air Force One. Jack has not made a trip and will not be able to go to Japan.

Finally, you have previously disapproved a proposal to participate in the "roll out" ceremonies for the new F-15 at Luke Air Force Base. Bill Timmons has sent you the attached memo asking you to reconsider.

My view is that you should stick with the original decision. Attending the ceremony involves adding another event, an extra motorcade of some thirty minutes, and would substantially reduce the preparation time available for the televised press conference with Sigma Delta Chi.

#### TRIP OVERVIEW

On Thursday, November 14, the President will address the National Association of Realtors at their 67th Annual Convention in Las Vegas, Nevada. He will then travel to Phoenix, Arizona, where he will conduct a press conference before The Society of Professional Journalists (Sigma Delta Chi) at that organization's 65th Annual Convention.

The President will return to Washington upon completion of the press conference.

It is recommended that the President accept Mr. Marriott's offer. It is also noteworthy that the Town House, the site of the press conference, is booked to capacity, and could not accommodate the President or his staff and guests without inconveniencing hotel guests.

As you may know, the first F-15 is to be delivered to Luke Air Force Base on November 15th. As Chairman of the Military Affairs Committee of the Phoenix Metropolitan Chamber of Commerce, I have arranged with the Luke Commander, Brigadier General Fred Haeffner, and General Robert Dixon, Commander of TAC, to hold our monthly dinner meeting at Luke that day in order to allow members and guests to see the aircraft and receive a briefing by General Dixon. Prior to your dinner with the Governors this evening, they will have met in Governor Busbee's suite in the Hyatt Regency to discuss the presentations they will be making to you. Governor Askew has been trying to put together such a meeting over the weekend in order to achieve a unified Democratic position.

Governor Edwards (R), South Carolina will attend and has been briefed on your economic and energy proposals. He will try to dissuade them from a resolution of opposition and Governors Waller (D) Mississippi and Edwards (D), Louisiana will likely be more supportive of you than of the Democratic alternative. Therefore, while we cannot be sure, it is likely that support for your position will come from Edwards (R), South Carolina; Holshouser (R), North Carolina; Waller (D), Mississippi and Edwards (D), Louisiana. The Democratic alternative, whatever it turns out to be, will likely by supported by the other Democrats including Askew, Florida; Wallace, Alabama; Blanton, Tennessee and Busbee, Georgia
