SUBJECT: The President's Activity Log,
Vail, Colorado.

Per your request, I've compiled from the daily logs a composite log indicating how the President has spent his time since his departure from Washington, D. C. on August 10th.

At Tab A is the summary of activities by time employing four categories. Category I, Staff Time, includes all scheduled and non-scheduled working time spent with White House and Administration personnel, including phone calls. Category II, Working Schedule - Public Events, Appointments and Activities, includes all non-staff outside working appointments, speeches, meetings, tours, GOP functions, public events, etc. Category III, Tennis/Golf, is self-explanatory. Category IV, Private Work, incorporates the President's personal work time, including the reading of the Daily Intelligence Brief and the President's News Summary; work on "blue folders" (Presidential Action/Signature Papers, etc.); reading of newspapers; work on speeches in the limousine; etc. It was necessary to make some estimates in this area, but I am confident they are very close to the mark.

Tab B is a narrative summary of the major schedule events.

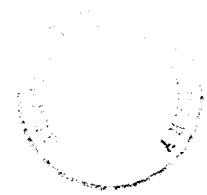
Tab C is a list of Governors, Mayors, Senators and Congressmen with whom the President has met.

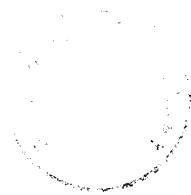

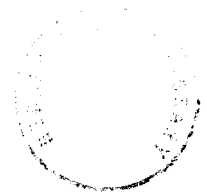

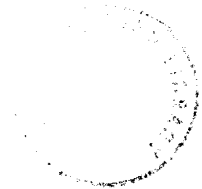
