The format for our county and precinct analysis of ticket-splitting is now finalized. Subsequent to our discussion, the format will closely resemble the format of April 27. The changes we will discuss. The counties/precincts are to be ranked according to their contribution to total presidential vote in 1968.

The entire project should be completed by July 1. Each completed state is to be delivered on an as-ready basis.


As soon as possible I will provide you with a list of ticket-leaders and base races. For those states that had no base race in '68 we will use another year with the same formula.
