Purpose

Provides for the appointment or reappointment of citizen regents to the Board of Regents of the Smithsonian Institution for terms of six years.


Discussion

Existing law (20 U.S.C. 42) provides that the Board of Regents of the Smithsonian Institution be composed of the Vice President, the Chief of Justice of the United States, three Members of the Senate, three Members of the House of Representatives, and nine other persons, other than Members of Congress. The nine citizen regents are to be appointed by joint resolution of Congress for six-year terms.



Pursuant to that law, the Board of Regents voted unanimously to request Congressional members of the Board to introduce legislation to provide for the reappointments of Drs. William A.M. Burden and Caryl P. Haskins and the appointment of Dr. Murray Gell-Mann to a position vacated by Dr. Crawford H. Greenewalt on May 30, 1974.

These enrolled joint resolutions carry out the Board of Regents recommendations. The biographies of the three citizen regents concerned are set forth in the Committee reports.

Thank you for referring to the Smithsonian Institution for comment enrolled bill S. J. Res. 220 providing for the appointment of Dr. William A. M. Burden as citizen regent of the Board of Regents of the Smithsonian Institution.

The manner of appointment and terms of office of Regents of the class other than members of Congress are set forth in 20 U. S. C. 43. At its meeting on May 14, 1974, the Board of Regents voted unanimously to request Congressional members of the Board to introduce legislation to provide for the reappointment of Dr. Burden, whose current term expired on July 2, 1974, for the statutory term of six years.

Dr. Burden is a resident of New York, and was initially appointed to the Board of Regents on July 2, 1962. He has served the Institution with distinction and is a member of the Executive Committee of the Board of Regents which is described in 20 U. S. C. 44. A biography of Dr. Burden is enclosed.

There are no initial or recurring costs or savings to the Government under this measure.

The Smithsonian Institution respectfully recommends endorsement by the President of S. J. Res. 220.

PROVIDING FOR THE REAPPOINTMENT OF DR. WILLIAM A. M. BURDEN AS CITIZEN REGENT OF THE BOARD OF REGENTS OF THE SMITHSONIAN INSTITUTION

Mr. NEDZI, from the Committee on House Administration, submitted the following

REPORT

[To accompany S.J. Res. 220]

The Committee on House Administration, to whom was referred the joint resolution (S.J. Res. 220), having considered the same, report favorably thereon without amendment and recommend that the joint resolution do pass.

By unanimous consent the Committee adopted a motion to report Senate Joint Resolution 220.

Senate Joint Resolution 220 would provide that Dr. William A. M. Burden, a resident of New York, be reappointed to the Board of Regents of the Smithsonian Institution of the class other than Members of Congress. This reappointment would be for the statutory term of six years. The Senate approved the joint resolution on July 15, 1974.

Dr. Burden, a former U.S. Ambassador to Belgium and consultant to the Departments of Commerce and Defense, has served on the Board of Regents since 1962.

Pursuant to 20 U.S.C. 42, the Board of Regents is composed of the Vice President, the Chief Justice of the United States, three Members of the Senate appointed by the President of the Senate, three Members of the House of Representatives appointed by the Speaker, and nine other persons other than Members of Congress. The nine Citizen Regents, two of whom shall be residents of the District of Columbia and seven of whom shall be residents of some State (but no two shall be inhabitants of the same State) are appointed by joint resolution of Congress to serve 6-year terms.

A report in further clarification of Senate Joint Resolution 220 addressed to the Hon. Wayne L. Hays, Chairman of the Committee on House Administration, by S. Dillon Ripley, Secretary of the Smithsonian Institution, is as follows:

[To accompany S.J. Res. 220]

The Committee on Rules and Administration, to which was referred the joint resolution, Senate Joint Resolution 220, to provide for the reappointment of Dr. William A. M. Burden as citizen regent of the Board of Regents of the Smithsonian Institution, having considered the same, reports favorably thereon without amendment and recommends that the joint resolution do pass.

Senate Joint Resolution 220 would provide that the vacancy in the Board of Regents of the Smithsonian Institution, of the class other than Members of Congress, which occurred by the expiration of the term of Dr. William A. M. Burden, New York, N. Y., on July 2, 1974, be filled by the reappointment of the present incumbent for the statutory term of six years.

The Board of Regents, pursuant to 20 U.S.C. 42, is composed of the Vice President, the Chief Justice of the United States, three Members of the Senate, three Members of the House of Representatives, and nine other persons, other than Members of Congress. The nine citizen regents, two of whom shall be residents of the District of Columbia and seven of whom shall be inhabitants of some State (but no two of the same State), are appointed by joint resolution of Congress and serve 6-year terms.

DEAR MR. CHAIRMAN: Thank you for requesting the comments of the Smithsonian Institution on Senate Joint Resolution 220 to provide for the reappointment of Dr. William A. M. Burden as citizen regent of the Board of Regents of the Smithsonian Institution.

The manner of appointment and terms of office of regents of the class other than Members of Congress are set forth in 20 U.S.C. 43. At its meeting on May 14, 1974, the Board of Regents voted unanimously to request Congressional members of the Board to introduce legislation to provide for the reappointment of Dr. Burden, whose current term expired on July 2, 1974, for the statutory term of six years.

Dr. Burden is a resident of New York, and was initially appointed to the Board of Regents on July 2, 1962. He has served the Institution with distinction and is a member of the Executive Committee of the Board of Regents which is described in 20 U.S.C. 44.

A biography of Dr. Burden is enclosed, and I shall, of course, be happy to furnish any additional information you may require.
