Discussion


Under present law, owners or operators of farms may lease
and transfer their acreage-poundage marketing quotas or
allotments for flue-cured tobacco to other farms in the
same county.

For 1974 only, H.R. 16857 would amend the law cited above
to allow the owners or operators of farms in Craven,
Carteret, and Jones Counties, North Carolina, to lease any
or all of their tobacco allotment or quota to any other
owner or operator in the same county or nearby counties
within the State who have farms having a current tobacco
allotment or quota of the same kind. However, as a



condition for such leasing, the Secretary of Agriculture would first have to determine that as a result of a natural disaster in a designated county (1) 10 percent or more of the planted tobacco acreage had been lost, and (2) that such leasing would not impair the effective operation of the tobacco marketing quota or price support program.

In its views letter on the enrolled bill, Agriculture notes that "enactment of the bill will not result in any additional expenditures of administrative or CCC capital funds."

Discussion

Under present law, owners or operators of farms may lease and transfer their acreage-poundage marketing quotas or allotments for flue-cured tobacco to other farms in the same county.

For 1974 only, H.R. 16857 would amend the law cited above to allow the owners or operators of farms in Craven, Carteret, and Jones Counties, North Carolina, to lease any or all of their tobacco allotment or quota to any other owner or operator in the same county or nearby counties within the State who have farms having a current tobacco allotment or quota of the same kind. Dear Mr. Ash:

In reply to the request of your office, the following report is submitted on the enrolled bill H.R. 16857, "To provide for emergency allotment lease and transfer of tobacco allotments or quotas for 1974 in certain disaster areas in North Carolina."

This Department recommends that the President approve the bill.

This bill is similar to Public Law 93-80, approved August 1, 1973. It authorizes for 1974 only the lease of flue-cured tobacco acreage-poundage marketing quotas from Craven, Carteret and Jones Counties, North Carolina, and transfer to farms in other nearby counties in the State, provided two conditions are met. First, the bill would not apply unless the Secretary determines that as a result of drought, flood, damage due to excessive rain, hail, wind, tornado, or other natural disaster, one of these counties has suffered a loss of 10 percent or more in the number of acres of tobacco planted. Secondly, that a lease will not impair the effective operation of the tobacco marketing quota or price support program.

Present legislation authorizes the lease of acreage-poundage marketing quotas for flue-cured tobacco and transfer to other farms in the same county. H.R. 16857 extends this authority to permit leasing of allotments and quotas for farms in Craven, Carteret and Jones Counties and transfer to farms in other nearby counties, under the conditions outlined above.

The enactment of the bill will not result in any additional expenditures of administrative or CCC capital funds.

An Act

To provide for emergency allotment lease and transfer of tobacco allotments or quotas for 1974 in certain disaster areas in North Carolina.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That section 316 of the Agricultural Adjustment Act of 1938, as amended, is amended by adding at the end thereof the following new subsection (h) :

“(h) Notwithstanding any provision of this section, when as a result of drought, flood, damage due to excessive rain, hail, wind, tornado, or other natural disaster, the Secretary determines (1) that one of the counties hereinafter listed has suffered a loss of 10 per centum or more in the number of acres of tobacco planted, and (2) that a lease of such tobacco allotment or quota will not impair the effective operation of the tobacco marketing quota or price support program, he may permit the owner and operator of any farm within Craven, Carteret and Jones Counties, North Carolina, which has suffered a loss of 10 per centum or more in the number of acres of tobacco planted of such crop to lease all or any part of such allotment or quota to any other owners or operators in the same county, or nearby counties within the same State, for use in such counties for the year 1974 on a farm or farms having a current tobacco allotment or quota of the same kind. In the case of a lease and transfer to an owner or operator in another county pursuant to this subsection, the lease and transfer shall not be effective until a copy of the lease is filed with and determined by the county committee of the county to which the transfer is made to be in compliance with the provisions of this subsection.”.
