



Francis Muir Scarlett was born in Glynn County, Georgia, on June 9, 1891, the son of Francis Muir and Bessie Brailsford Scarlett. He remained a resident of Glynn County until the day of his death on November 18, 1971.

Judge Scarlett was educated in the public schools of Glynn County until 1908 when he attended Gordon Military Institute in Barnsville, Georgia, from which he graduated in 1910. He entered the University of Georgia School of Law in 1910 and graduated with an LLB degree in 1913. He returned to Brunswick and began the practice of law. His first public office was Solicitor of the City Court of Brunswick which he held for ten years and established himself as an able trial lawyer.
