The purpose of the bill is to grant the status of permanent residence in the United States to Hendrika Koenders Lyne. The bill provides for the payment of the required visa fee and for an appropriate visa number deduction.

STATEMENT OF FACTS

The beneficiary of the bill is a 44-year-old native and citizen of the Netherlands who entered the United States as a visitor on December 3, 1971. She married a native-born U.S. citizen in Holland on May 4, 1962. Her husband was then on active duty with the U.S. Marine Corps, but retired shortly thereafter. Two children born of this marriage acquired U.S. citizenship at birth through their father. In August 1969 the beneficiary's husband left his family and ceased support. Mrs. Lyne, unable to provide for herself and her sons, sought legal advice at the American airbase in Madrid. At the suggestion of

personnel in that office, she came to the United States to seek her husband in December 1971.

A letter, with attached memorandum, dated December 12, 1973, to the chairman of the Committee on the Judiciary of the House of Representatives from the Commissioner of Immigration and Naturalization refers to H.R. 9790, a similar bill introduced in the 93d Congress. Two United States children born of their marriage reside with the beneficiary in Silver Spring, Maryland. The beneficiary's husband resides in Lake Porte, California, They are legally separated; however, she alleges they have been divorced but she has not received legal proof. Since 1972, she had been receiving \$120 monthly toward the support of the children. She had been employed as a part-time housekeeper in a private home and earned \$60 weekly, but at present is temporarily unemployed due to a foot injury. She attended school for fifteen years in her native country, having graduated from high school and completed a course in typing and housekeeping. She claims no assets. Her parents reside in Holland. She has no brothers or sisters.

The beneficiary was admitted to the United States on December 3, 1971, as a nonimmigrant visitor. Extensions of stay were authorized to December 3, 1973. The beneficiary has evinced an intention to remain in the United States permanently, thereby terminating her nonimmigrant status. Deportation proceedings were instituted against her on November 7, 1973, having remained in the United States for a longer time than permitted.

Upon the granting of permanent residence to such alien as provided for in this Act, the Secretary of State shall instruct the proper officer to deduct one number from the total number of immigrant visas and conditional entries which are made available to natives of the country of the alien's birth under paragraphs (1) through (8) of section 203(a) of the Immigration and Nationality Act.
