Pettis, former Member of the House of Representatives from 1967-1975. The enrolled bill also would authorize the VA Administrator to provide an appropriate memorial at the hospital for the late Congressman.

The new 500-bed VA hospital is located in the 37th Congressional District of California, which was represented by the late Rep. Pettis, and is currently represented by his widow. It is scheduled to open in the fall of 1977 and will be affiliated with the Loma Linda Medical School.

As noted in the attached VA views letter, Jerry L. Pettis actively supported the establishment of the new VA hospital. He maintained a long affiliation with Loma Linda University, serving as Professor, Vice President and Chairman of the

Board during the period 1948 to 1967, and was influential in the planning and development of the Loma Linda Medical School.

While it is not the general practice to name VA hospitals for individuals, there are exceptions. VA hospitals have been named for Royal C. Johnson, the first chairman of the Committee on World War Veteran Legislation, Presidents Franklin Delano Roosevelt and Harry S. Truman, Speaker Sam Rayburn, and World War II Medal of Honor winner Audie L. Murphy.

H.R. 4034 and several identical bills have bipartisan sponsorship of the entire California delegation. We concur with the VA recommendation that H.R. 4034 be approved.

This will respond to the request of the Assistant Director for Legislative Reference for the views of the Veterans Administration on the enrolled enactment of H.R. 4034, 94th Congress, a bill "To designate the Veterans' Administration hospital in Loma Linda, California, as the 'Jerry L. Pettis Memorial Veterans' Hospital', and for other purposes."

The subject bill would, as indicated by the title, designate the Veterans Administration Hospital in Loma Linda, California, as the Jerry L. Pettis Memorial Veterans' Hospital, and authorize the Administrator to provide such memorial at that hospital as he deems suitable to preserve the remembrance of the late Jerry L. Pettis.

Mr. Pettis served honorably and with distinction in the House of Representatives of the United States Congress since his election in 1966. He was vitally concerned with the health of all Americans, including veterans, their widows, and orphans. He served during World War II as an instructor and pilot with the Air Transport Command in the Pacific Theater. He actively supported the establishment of the VA Hospital now being constructed at Loma Linda, California. He served as Professor of Economics at Loma Linda University from 1948 to 1964, Vice President of the University from 1960 to 1964, and Chairman of its Board from 1960 to 1967. He was also a rancher, businessman, and an airline pilot.

The Veterans Administration has long followed a policy of naming its hospitals for the locality where situated, and not for individuals. This long-standing policy has been based upon the realization that a fair basis of selection would be difficult, that controversy might result in some instances, and that persons or organizations whose candidates were not chosen would be disappointed.

Veterans Administration hospitals named by Congress are not subject to this administrative policy, and five have been so named. They are the Royal C. Johnson Veterans Memorial Hospital at Sioux Falls, South Dakota (Public Law 93, 79th Congress, June 29, 1945), the Franklin Delano Roosevelt Hospital at Montrose, New York (Public Law 189, 79th Congress, September 26, 1945), the Sam Rayburn Memorial Veterans Center at Bonham, Texas (Public Law 91-421, September 25, 1970), the Audie L. Murphy Memorial Veterans' Hospital at San Antonio, Texas (Public Law 92-183, December 15, 1971), and the Harry S. Truman Memorial Veterans' Hospital at Columbia, Missouri (Public Law 93-602, January 2, 1975).

In view of Mr. Pettis' distinguished Congressional service, it is quite understandable that consideration should be given to honoring him. Accordingly, I recommend that the President approve H.R. 4034.

BIOGRAPHY OF JERRY L. PETTIS

Jerry Lyle Pettis was born in Phoenix, Arizona, on July 18, 1916. He took his preparatory school education in the Thunderbird S.D.A. Academy in Phoenix. He attended Pacific Union College in Napa County, California, graduating with high honors. His further formal education included masters' degree and doctoral course work at the University of Denver and later at the University of Southern California. He later taught speech at Union College, Nebraska, and was Professor of Economics at Loma Linda University.

During his early years, Mr. Pettis became a Seventh-day Adventist minister pastoring churches in Arizona and Colorado. He was the first Seventh-day Adventist to ever be elected to the Congress of the

United States.

Following Pearl Harbor he became an organizer of the Civil Air Patrol. In the last two years of World War II, he was a pilot and flight instructor with the Air Transport Command in the Pacific Theater.

After the war he became a pilot for United Airlines. He later served as special assistant to the president of the company. At the time of his death, Mr. Pettis was a member of the Air Line Pilots Association

(AFL-CIO).

He then entered into the world of business where he founded four major companies. He became an inventor, innovator and motivator, all directed toward helping his fellow man. He founded the Magnetic Tape Duplicators—the world's largest user and duplicator of magnetic tape. He also established the Audio Digest Foundation, a non-profit organization furnishing monthly education tapes to physicians to keep them abreast of new developments in their field. Foundation earnings are held in a trust fund and are used to provide scholarships for needy medical students throughout the United States.

Mr. Pettis served as Executive Secretary of the California Medical Association. His expertise in the field of medicine and health care served him later in good stead in his political life. He was vice president for Public Affairs and Development for the Adventist Medical School, now known as the Loma Linda Medical School. He was influential in the planning and establishment of the magnificent 450-bed

Medical Center Building at the school.

Mr. Pettis was first elected to the 90th Congress November 8, 1966. He was reelected to the 91st, 92nd, 93rd, and 94th Congresses, serving with distinction as a member of the Science and Astronautics (Science and Technology) and Ways and Means Committees.

Mr. Pettis was a husband, father, churchman, businessman, pilot, farmer, educator and Congressman. He died on February 14, 1975, at

the age of 58.

JUSTIFICATION FOR THE BILL

While it is not the general practice to name Veterans' Administration hospitals for individuals, there are exceptions. The first hospital

named (under Public Law 93, 79th Congress) was for Royal C. Johnson, the first chairman of the Committee on World War Veteran Legislation. That hospital is located at Sioux Falls, South Dakota. By Public Law 79–189, the hospital at Montrose, New York was designated as the "President Franklin Delano Roosevelt VA Hospital." By Public Law 91–421, the hospital and domiciliary complex at Bonham, Texas was designated as the "Sam Rayburn Memorial Veterans' Center." In December, 1971, by Public Law 92–183, the new hospital at San Antonio, Texas was designated as the "Audie L. Murphy Memorial Veterans' Hospital." Finally, on January 2, 1975, by Public Law 93–602, the hospital at Columbia, Missouri was designated as the "Harry S. Truman Memorial Veterans' Hospital."

More than any other man, Mr. Pettis worked for the establishment and construction of the 550-bed Loma Linda Veterans' Administration Hospital, located near the Loma Linda Medical School and Medical Center. It is one of the Agency's most modern facilities, serving

thousands of veterans throughout the region.

The committee notes that this bill represents bipartisan sponsorship

of the entire California delegation.

OVERSIGHT FINDINGS

Pursuant to clause 2(1)(3)(A) of rule XI of the Rules of the House of Representatives, the committee issues the following oversight findings:

No oversight hearings have been held relative to the reported bill. In regard to clause 2(1)(3)(D) of rule XI, no oversight findings have been submitted to the committee by the Committee on Government Operations.

In regard to clause 2(1)(3)(C) of rule XI, no cost estimate or comparison has been submitted by the Congressional Budget Office relative

to the provisions of the reported bill.

INFLATIONARY IMPACT STATEMENT

With respect to clause 2(1) (4) of rule XI, the reported bill will have no inflationary impact.

COST

There would be no additional expense to the Treasury as a result of the enactment of the first section of the bill. When implemented by the Administrator, Section 2 will perhaps involve some expense but it would be relatively insignificant.

The House Committee favorably reported H.R. 4034 on September 18, 1975. Subsequently, on October 6, 1975, the measure was unanimously passed by the full House of Representatives. Following receipt of the views of the Veterans' Administration, the Senate Committee on Veterans' Affairs met in open executive session on March 10, 1976, and unanimously ordered H.R. 4034 reported favorably to the full Senate.

BACKGROUND AND DISCUSSION

Jerry Lyle Pettis was born in Phoenix, Arizona, on July 18, 1916. He took his preparatory school education in the Thunderbird S.D.A. Academy in Phoenix. He attended Pacific Union College in Napa County, California, graduating with high honors. His further formal education included masters' degree and doctoral course work at the University of Denver and later at the University of Southern California. He later taught speech at Union College, Nebraska, and was Professor of Economics at Loma Linda University.

During his early years, Mr. Pettis became a Seventh-day Adventist minister pastoring churches in Arizona and Colorado. He was the first Seventh-day Adventist ever elected to the Congress of the United States.

Following Pearl Harbor, he became an organizer of the Civil Air Patrol. In the last two years of World War II, he was a pilot and flight instructor with the Air Transport Command in the Pacific Theater.

After the war, he became a pilot for United Airlines and later served as special assistant to the president of the company. At the time of his death, Mr. Pettis was a member of the Air Line Pilots Association (AFL-CIO).

Mr. Pettis then entered into the world of business where he founded four major companies. He became an inventor, innovator and motivator; all directed toward helping his fellow man. He founded the Mag-

netic Tape Duplicators—the world's largest user and duplicator of magnetic tape. He also established the Audio Digest Foundation, a non-profit organization which furnishes monthly education tapes to physicians to keep them abreast of new developments in their field. Foundation earnings are held in a trust fund and are used to provide scholarships for needy medical students throughout the United States.

Mr. Pettis served as Executive Secretary of the California Medical Association. His expertise in the field of medicine and health care served him later in good stead in his political life. He was vice president for Public Affairs and Development for the Adventist Medical School, now known as the Loma Linda Medical School. He was influential in the planning and establishment of the magnificent 450-bed Medical Center Building at the school.

Mr. Pettis was first elected to the 90th Congress November 8, 1966. He was reelected to the 91st, 92d, 93d, and 94th Congresses, serving with distinction as a member of the Science and Astronautics (Science and Technology) and Ways and Means Committees.

Mr. Pettis was a husband, father, churchman, businessman, pilot, farmer, educator, and Congressman. He died on February 14, 1975, at

While it is not the general practice to name Veterans' Administration hospitals for individuals, there are exceptions. The first hospital named (under Public Law 93, 79th Congress) was for Royal C. Johnson, the first chairman of the Committee on World War Veteran Legislation. That hospital is located at Sioux Falls, South Dakota. By Public Law 79–189, the hospital at Montrose, New York was designated as the "President Franklin Delano Roosevelt VA Hospital." By Public Law 91–421, the hospital and domiciliary complex at Bonham, Texas was designated as the "Sam Rayburn Memorial Veterans' Center." In December, 1971, by Public Law 92–183, the new hospital at San Antonio, Texas was designated as the "Audie L. Murphy Memorial Veterans' Hospital." Finally, on January 2, 1975, by Public Law 93–602, the hospital at Columbia, Missouri was designated as the "Harry S. Truman Memorial Veterans' Hospital."

No man worked more diligently than Mr. Pettis for the establishment and construction of the 500-bed Loma Linda Veterans' Administration hospital. The new VA hospital being constructed at Loma Linda, California will be a modern 500-bed general medical and surgical hospital located in southwestern San Bernadino County adjacent to the Loma Linda University Medical Center with which this hospital will have an active affiliation. The new hospital will employ about 1,350 employees.

The hospital will be a four-story structure of 724,000 square feet and will cost about \$56 million. The hospital's bed distribution will be: medical 190; surgical 150; neurological 40; psychiatric 60; and nursing home care 60. The hospital will also have facilities to provide the most up-to-date specialized medical programs including Alcohol Treatment, Cardiac Catheterization, Electron Microscopy, Hemodialysis, Home Dialysis Training, Hospital Based Home Care, Intensive Care, Nuclear Medicine, Orthotic Laboratory, Pulmonary Function Laboratory, Respiratory Care Center, and Speech Pathology. The hospital will also include facilities for education, training, and research activities.

The construction of this hospital is expected to be completed in the fall of 1977 with the actual hospital operations commencing in early 1978

The Committee notes that this bill represents bipartisan sponsorship of the entire California delegation.

COST ESTIMATES

In accordance with section 252(a) of the Legislative Reorganization Act of 1970 (Pub. L. 91-510, 91st Congress), the Committee, based on information supplied by the Veterans' Administration, estimates that there will be no additional cost resulting from the enactment of the first section of the bill. Section 2 which authorizes a memorial will have an insignificant cost impact when implemented by the Administrator.

AGENCY REPORT

The Committee requested and received a report from the Veterans' Administration on H.R. 4034, as passed by the House. That report follows:

Dear Mr. Chairman: This will respond to your request for a report by the Veterans' Administration on a bill which passed the House of Representatives on October 6, 1975, H.R. 4034, 94th Congress, "To designate the Veterans' Administration hospital in Loma, Linda, California, as the 'Jerry L. Pettis Memorial Veterans' Hospital', and for other purposes."

The subject bill would, as indicated by the title, designate the Veterans' Administration hospital in Loma Linda, California, as the Jerry L. Pettis Memorial Veterans' Hospital, and authorize the Administrator to provide such memorial at that hospital as he deems suitable to provide the designation of the contraction of the contractio

able to preserve the remembrance of the late Jerry L. Pettis.

Mr. Pettis served honorably and with distinction in the House of Representatives of the United States Congress since his election in 1966. He was vitally concerned with the health of all Americans, including veterans, their widows, and orphans. He served during World War II as an instructor and pilot with the Air Transport Command in the Pacific Theater. He actively supported the establishment of the VA hospital now being constructed at Loma Linda, California. He served as Professor of Economics at Loma Linda University from 1948 to 1964, Vice President of the University from 1960 to 1964, and Chairman of its Board from 1960 to 1967. He was also a rancher, businessman, and an airline pilot.

It is the usual practice of the Veterans' Administration to name its hospitals for the locality where situated, and not for individuals. This long-standing policy has been based upon the realization that a fair basis of selection would be difficult, that controversy might result in some instances, and that persons or organizations whose candi-

dates were not chosen would be disappointed.

Veterans' Administration hospitals named by Congress are not subject to this administrative policy, and five have been so named. They are the Royal C. Johnson Veterans' Memorial Hospital at Sioux Falls, South Dakota (Public Law 93, 79th Congress, June 29, 1945), the Franklin Delano Roosevelt Hospital at Montrose, New York (Public Law 189, 79th Congress, September 26, 1945), the Sam Rayburn Memorial Veterans' Center at Bonham, Texas (Public Law 91–421, September 25, 1970), the Audie L. Murphy Memorial Veterans' Hospital at San Antonio, Texas (Public Law 92–182, December 15, 1971), and the Harry S. Truman Memorial Veterans' Hospital at Columbia, Missouri (Public Law 93–602, January 2, 1975).

In view of Mr. Pettis' distinguished Congressional service, it is

In view of Mr. Pettis' distinguished Congressional service, it is quite understandable that consideration should be given to honoring him. Favorable Congressional action on the subject bill would have

the Veterans' Administration's support.

We were advised by the Office of Management and Budget in regard to a report on the subject bill to the Chairman of the House Committee on Veterans' Affairs, that there was no objection to the presentation of that report from the standpoint of the Administration's program.

An Act

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Veterans' Administration hospital at Loma Linda, California, shall hereafter be known and designated as the "Jerry L. Pettis Memorial Veterans' Hospital". Any reference to such hospital in any law, regulation, document, record, or other paper of the United States shall be deemed a reference to it as the Jerry L. Pettis Memorial Veterans' Hospital.

Sec. 2. The Administrator of Veterans' Affairs is authorized to provide such memorial at the above-named hospital as he may deem suitable to preserve the remembrance of the late Jerry L. Pettis.
