GENERAL STATEMENT

Former U.S. Senator Norris Cotton was born in Warren, New Hampshire on May 11, 1900. He attended the Tilton School and Phillips Exeter Academy, and at age 22 was elected to the New Hampshire State Legislature. Senator Cotton graduated from Wesleyan University in 1923, and later worked his way through George Washington University Law School by serving as a secretary to Senator George Moses. He was admitted to the New Hampshire Bar Association in 1928.
