INTRODUCTION

The United States-China Business Council audiovisual materials consist of photographs and audio tapes removed from the papers US-China Business Council. Many of the photographs document fact-finding trips to the People's Republic of China (PRC) by representatives of various U.S. industries, including textiles, agriculture, petroleum, metallurgy, and construction. In some cases passport portraits of the delegates are included. Other photographs show reciprocal visits to the United States by Chinese delegates.

The audio tapes primarily document US-China Business Council sponsored conferences, including the Council's inaugural meeting in May 1973; a PRC delegation meeting with the San Francisco Chamber of Commerce; and Agriculture and Mining conferences. Other tapes report on projects under the auspices of the US-China Business Council.

ARRANGEMENT

The photographs are arranged as a parallel file to the manuscript collection. The audio tapes, which arrived unarranged, have been arranged chronologically.
