1973-74 - U.S. Ambassador to NATO

1974-75 - Assistant to the President for White House Operations (Chief of Staff)

1975-77 - Secretary of Defense

1977-2001 - In private business serving successively as President of G. D. Searle & Company, CEO of the General Instrument Corporation, and Chairman of Gilead Sciences, Inc.
