Re: Report Filing

Dear Sirs:

We are today filing our first monthly report (January 1-31, 1976) with the Commission. It is our understanding that monthly reporting eliminates the need for pre- and post-election reports with respect to each primary election.

During the month of January all of Governor Reagan's campaign expenses were handled through our committee, his principal campaign committee. The Governor made no campaign expenditures, made no financial campaign contributions to our campaign and received no contributions for the campaign. All financial matters relating to Governor Reagan's campaign go through Citizens for Reagan. We, therefore, presume it is proper for us to file FEC Form 3a/January 1976 on behalf of Governor Reagan personally. If this is not the case, please inform us as soon as possible.

Over the past several months our committee has filed with the Commission information on our state subdivisions. This information may be treated as an update of our initial registration statement, if the Commission feels that is appropriate. In the last few days, we have received various multiple mailings to our address, one per state subdivision. Our committee does not consider nor treat our state units as separate political committees. They are merely subdivisions of our registered committee. We include their expenditures in our reports. They do not receive contributions on their own, but forward any contributions collected to us. They, therefore, do not require independent identification numbers or mailings of Commission materials.



In our report for the month of January we are including all funds sent by our committee to our state subdivisions. This, of course, reflects our direct total expenditures in each of the states. However, in the case of several states, the detailed itemized information on expenditures of the money sent to them is apparently still in the mail. This is also true of some subdivision bank statements which come directly to our committee for reconciliation and expenditure reporting. It is our intention to obtain the additional information as soon as possible. We will include it with our February report. If the Commission prefers, however, we will file it as an amendment to our January report. We would appreciate any guidance the Commission chooses to give in this matter.

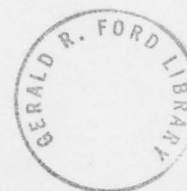
