

Mary Stevens Carroll the Older Americans Coordinator in Montana telephoned the Older Americans Desk this morning to say "As I listened to Jimmy Carter debate the President last night on his conduct of foreign affairs, I heard him take on a belligerent tone. He said, "I would consider another Arab boycott an act of economic warfare and I could act accordingly!!" - then I heard the President tell of his efforts to stabilize things in the Middle East, Asia and Africa. I realize we are "at peace" thank God! No boy is facing the draft and an awful thought struck me. Every war in this century has been under a Democratic president. World War I under Woodraw Wilson, World War II under Roosevelt, Korean conflict under Trumann and Vietnam under President Johnson.

The peanut farmer from Georgia is appealing but if the debate showed anything, it revealed a lack of knowledge and experience in foreign policy by the man from Georgia and his tone when he said, " I would consider another Arab boycott an act of economic warfare and I will act accordingly!!"
