As an alternative to contracting with a California vendor for the production of our voter phone lists for the June Primary, we have decided to buy our phone lists from the Republican National Committee. The RNC is currently in the process of reformatting voter files which they have received from the Secretary of State's Office in California. These files will be converted into a common format and matched against a phone list for the State. RNC is willing to cover all the costs of collection, conversion and matching, and will charge the President Ford Committee for the actual printing and paper for the listing we request. It is my understanding that this price will be \$1.25 per thousand lines printed. It is my judgement that they will be able to deliver this data in time for use by our phone banks. This means that we should have all material in hand by April 10.

I have been in contact with Murray Dickman at RNC, and he has assured me that they can meet this deadline. I feel, however, that a letter should be sent from the national President Ford Committee to the appropriate level in RNC to assume that all concern realize that the California Campaign is depending upon this delivery and that it will indeed be giving the priority that Murray Dickman assures me that it will get (Sometimes priorities are changed from above....). Our requirements must be met or the phone program cannot start on time (April 15).

California and Wisconsin Issues Update

There have been no new developments in Wisconsin since my first memorandum for you with the exception of the following somewhat "back burner" issue.

Mississippi Barge Canal Transportation Subsidy

The U.S. Army Corps of Engineers has been rebuilding many of the water freight facilities on the Mississippi River to revitalize the barge shipping industry. There is some concern in Wisconsin that the Federal government is funding these activities at the expense of the railroads -- a transportation system on which manufacturing and farm interests are heavily dependent.

Regarding California, I attach an update which should be integrated with the original issues outline. Let me also point out an error in the first memorandum which should be corrected. The appropriations request for the state Agriculture Labor Relations Board should read as \$3.8 million and not as \$86,000. An update on this subject is provided in the attached material.

CALIFORNIA ISSUES UPDATE

Agriculture

Last week, the California Assembly passed a bill to reduce to \$2.55 million the amount of funding for the Agriculture Labor Relations Board. The Democrat farm-area legislators had previously blocked the bill, however they fell into a party-line vote to pass the measure. It is anticipated that the Senate will not pass the bill unless the access rule is changed.

In the California "farm belt", a lack of rainfall has brought on a mini draught. Governor Brown has asked that emergency status be given this affected area for relief funding.

While the Caesar Chavez United Farm Workers controversy is still alive, it is overshadowed at this time by the Agricultural Labor Relations Board issue.

Crime

Questions should be anticipated on the gun control issue. Approximately 95% of the California GOP audience is believed to be opposed to gun control--however, in the interests of the general electorate, addressing this issue in remarks is not recommended by state sources.

While there has been a highly positive reaction to Patty Hearst's conviction, answers to anticipated questions should only reflect disinterest by the President in order to avoid any repeat of the off-the-cuff Nixon comment on the Manson trial. F. Lee Bailey has indicated that an appeal of the conviction will be made.

Defense

Reagan has scored points with the press coverage of his attacks on detente and national defense. A confident, reassuring statement on the strength of our defense posture would be apropos at this time.

In terms of the state's defense contractors, McDonald/Douglas has had to cut back on some 4500 jobs due to a lack of business; however General Dynamics in San Diego just won a major contract for cruise missiles.

Energy

Questions pertaining to the Exxon Corporation's intent to open another off-shore drilling platform can be anticipated, as the Los Angeles Times ran a large article on this issue on March 22.



Health

An additional consideration to the medical malpractice premiums/ doctor's strike issue is the doctors' growing reluctance to treat Medical (California Medicaid) patients by reason of increasing malpractice insurance costs.

While the President's catastrophic health insurance proposal was favorably received, public interest in the issue is not significant at this time.

Economy

The national economic climate is producing a favorable increase in housing starts. A comparison of the number of building permits issued in California from January, 1975 to January of 1976 shows an increase of over 200%.

Foreign Policy

The attitude of Republican voters as well as that of the general electorate toward the Panama Canal is strong for keeping the Canal a U.S. possession. Reagan has received substantial play in the state of his criticism of the current negotiations.

Illegal Aliens

While some questions may be anticipated, public feeling in general supports the view that more stringent enforcement of immigration laws is necessary.

Social Security

Public reaction to the President's Social Security program is extremely positive. The President's soft insistence of his own plan is being received far better than the harsh criticism Reagan is generating.

Nixon Trip to China

While there has been no extensive play on Nixon's China trip, some reverberations have been received in California, and the President should anticipate questions as to the purpose of Nixon's trip and the former President's well publicized posttrip assessment.

Presidential Candidates

Governor Jerry Brown's recently declared candidacy for the Democratic nomination is a subject of considerable state interest. The Governor's philosophy with regard to limited government and his austere personal style have evoked extremely favorable approval ratings among California voters. Brown has yet to formulate any national campaign platform, and has stated he will not be a candidate in any primary outside of California.



REAGAN ON THE ISSUES

Ronald Reagan delivered his standard campaign speech in Oshkosh on January 13 in which he warned the audience of the perils of a burgeoning Federal bureaucracy. In a question and answer session that followed, Reagan responded to the following areas of concern.

Big Business

"Today the belief that big business can move government to its will is no longer true." Regan said. "Business has less power in the nation's capital than almost any other group." Reagan defended Federal subsidies to Lockhead Aircraft Corporation because "it was done in the name of national security." He added that he had been critical of business in the past for soliciting government subsidies as well as regulations that limit competition.

Labor Unions

Reagan commented that he thought labor leaders were too powerful and that union members should have the right to secret ballots on union affairs, including strikes.

Detente

Reagan reitereated his oft-quoted phrase that detente had become "a one way street".

Agriculture

In Danville, Illinois, on March 9, (two days before his second trip to Wisconsin) Reagan made several comments regarding dairy subsidies which are subsidizing those who could not compete at the expense of those who could possibly bring the price down in the marketplace," Reagan siad. "You subsidize the inefficient when you put a floor under the market price," he added.

California has a strictly regulated milk price system which was never changed during Reagan's tenure as Governor. However, Reagan said, "I tried to convince the dairy industry it was against its best interest when it prefers the security of the government protection or against the open market competition."



WISCONSIN DELEGATE SELECTION

There are a total of 45 Convention delegates at stake in the April 6 primary. Four delegates are apportioned to each of the state's nine Congressional Districts with the remaining nine delegates to be selected at-large. Both the statewide at-large delegates and those selected on a Congressional District level will be determined by the "winner-take-all" rule.

Delegates are bound at the National Convention for the first ballot and for all subsequent ballots as long as the candidate to whom they are bound receives no fewer than one-third of the total Convention votes. A candidate may, however, release his pledged delegates at any time.

It should be noted that only the candidate's name will appear on the primary ballot. The state GOP has until June 1 to select delegate states and each candidate to whom delegates are bound has until June 5 to approve the state. In the event that suggested delegates are disapproved, the candidate can then file his own state.

Voters do not register by party; consequently, there is a "cross-over" potential of self-identified Republicans to defect to the Democrat primary and vice-versa. Registration closes ten days prior to the election.





As discussed on the telephone, we do not have any credible and current survey research data on California. Mervin Field's late January California Poll showed the President losing to Reagan among California Republicans in terms of their nomination preference. We do not put any stock in this particular survey, however, for reasons too extensive for the parameters of this memo. In terms of turnout projections for the California primary, it is much too early to estimate and there are no truly comparable races to use as a guide. The 1972 GOP Presidential primary drew nearly 2.3 million voters to the polls. The President will be attending the semi-annual Convention

The President will be attending the semi-annual Convention of the Republican State Central Committee of California (RSCCC). Delegates to the Convention are Party activists selected from throughout California who are appointed by GOP state office holders and candidates for state office. Winning Republican candidates are allowed to appoint 8 regular voting members to the Committee with losing candidates allowed to appoint 3 delegates. State sources estimate that approximately 1,200 persons will be present at the RSCCC luncheon, with about a 50-50 split in their support between President and Ronald Reagan. We have been advised to avoid all Reagan criticism. The best issue to plug is Party unity and GOP victory in November.

Incumbent state senator from Fresno, Howard Way, is retiring from the state legislature. Way is an active Ford supporter, and is currently serving as Chairman of the California Farmers for Ford. His seat is being sought by Assemblyman Ernest Mobley, who is uncommitted and is expected to win the primary and general election.

PFC CAMPAIGN OVERVIEW

There are 2,858,000 registered Republicans in California, comprising 37% of the total electorate. Registration will close May 9 on only registered Republicans eligible to vote in the June 8 primary.

Principal emphasis in PFC California strategy is on voter identification and selective voter turnout. Phone banks will again be the key tool in identifying the President's support, and the operational date for opening of all phone centers is April 19. Other key elements of the campaign include the following:

- 1. An estimated 80% of the registered Republicans will be covered in the priority counties. Precincts in each of the phone locations are now being prioritized and phone numbers of registered Republicans are currently obtained.
- 2. County and community organizations are also being formed with 51 out of the 58 counties, (and virtually all main vote areas) currently being organized.
- 3. Volunteer mailings numbering 52,000 pieces have been sent out by PFC county organizations as part of a recruitment drive.
- 4. County organizations are also being encouraged to utilize "in home" exemptions to hold receptions for recruitment and training purposes. Instruction kits have been mailed to key PFC personnel, and 20 receptions are tentatively set.
- 5. A California brochure is being developed for printing and distribution in April. Radio spots presently being developed are scheduled to run in the first part of April with emphasis on the President's record in office.
- 6. Press tours using Advocates and key President Ford volunteers in the state have been scheduled, and emphasis at this time is on meeting with the editorial boards of major papers to encourage primary endorsement of the President.



DELEGATE SELECTION

The California primary on June 8 is a "winner take all" race by which delegates to the Republican National Convention are bound through the second ballot, unless released or unless the candidate to whom they are bound receives fewer than 10 percent of the votes needed for the nomination on the first ballot.

There will be a total of 167 delegates in the California delegation. Three delegates are apportioned to each of the forty-three Congressional Districts for a total of 129 persons with the remaining 38 delegates to be selected at-large. The candidate's name will appear on the ballot and ballot position will be rotated.

Write-in votes are permitted under California law, but are counted only if the write-in candidate has filed an endorsement of his candidacy with the Secretary of State by May 18th.

As was the case in Florida, only registered Republicans may vote in the June 8 California GOP primary. A potential voter must register, change party affiliation or designate party affiliation by May 9 in order to qualify to vote.

REAGAN CAMPAIGN OVERVIEW

As of the end of last week, the only campaign activity visible in the state was with a number of Republican Women's Federation clubs. It is clear that Reagan is attempting to run his grassroots activities through the CFRW -- an organization which was solidly supportive of him during his tenure as Governor. It should not be inferred, however, that Reagan has a monopoly on Women's Federation backing. Immediate past president of the CFRW, Marie Solberg, is working actively in behalf of the President and has reported good success in lining up CFRW leadership and rank-and-file support.

Former Nixon youth director Ken Reitz, who was initially responsible for organizing California for Reagan, has apparently left the campaign to work for U.S. Senate candidate John Harmer. There is no phone campaign yet evident, and direct mailings have been solely of a fund raising nature. There is no evidence of any media activity at this time.

Although there have been press reports of sizable numbers of volunteers, the Reagan campaign does not appear to have an organizational mechanism to put them to work. The only activity in the last two to three weeks has been the appointment of leadership in several counties (i.e., Orange, San Diego, Kern, Marin, San Mateo and a portion of Los Angeles).

In short, the Reagan campaign has been extremely low profile.

REAGAN CAMPAIGN OFFICIALS

REAGAN ON THE ISSUES

Ronald Reagan has yet to make any statements specifically addressed to California voters regarding his bid for the nomination. He has returned to the state to rest from campaign activities, but has not used these visits to make any major statements to California voters.

Reagan has, however, frequently referred to his record as Governor as evidence of his qualifications to be President. His proposed \$90 billion plan was severely criticized by the state's major newspapers as an ill-considered plan and his claims on reducing the welfare roles while Governor have likewise been the subject of negative editorial comment.

PFC CAMPAIGN OVERVIEW

There is no statewide partisan registration required in Wisconsin; consequently, voter turnout projections are very difficult to predict. Of the approximately 3,134,000 persons of voting age, no more than 400,000 are expected to participate in the April 6 GOP primary based on previous turnout statistics. State sources indicate that "cross-over" voting does not appear to be the problem that it was in 1972.

The Wisconsin PFC has adopted four program activities to reach potential voters: voter identification phone calls; selective direct mailings; newspaper and broadcast media advertizing; and, a get-out-the-vote telephone effort on election day.

The centralized phone bank operation began on March 15 with 17 phone centers located in 18 cities with a population of 20,000 or more. Approximately 100 telelphones will be used to reach a prospective goal of 250,000 Republican households. A personalized letter from former Governor Knowles will be sent to identified undecideds who will in turn be called a second time if resources permit.

Direct mail drops consisting of a campaign '76 brochure and a letter from Governor Knowles are scheduled to be sent to 200,000 selected households on March 29. Moreover, a specified farm brochure along with a letter from a prominent state farmer will be mailed to individuals on lists acquired from the Farm Bureau and agri-business organizations.

A newspaper tabloid stressing such important state issues as agriculture and unemployment will be inserted in several major state newspapers on the Sunday preceding the primary. This special tabloid will also be distributed in areas not covered by newspapers distribution.

Recruitment and training of volunteer phones for get-out-the-vote activities on election day are currently underway. Projections call for more than 75,000 Republican households to be called with 50% of the completed calls to be made at centralized center with the balance of calls to be made by the home phone program.

Radio and television spots are scheduled to begin on Tuesday, March 16.

In terms of Presidential advocates, visits to the state are planned by Cabinet Secretaries Butz, Mathews, Richardson, and Simon. Mel Laird is scheduled to be in the state in your behalf

REAGAN CAMPAIGN OVERVIEW

Ronald Reagan has visited the state on only two occasions. On January 11, Reagan visited Jonesville and Oshkosh. At the latter stop, he delivered a speech at the University of Wisconsin, which was marred by heckling from a group of students. On March 11, Reagan made a trip to Milwaukee and Madison during which he appeared at a high school and a technical college. The campaign has said that the former Governor will spend a total of six more days in the state before the primary, which includes his visit to Green Bay on March 22.

The Reagan organization had a statewide telephone campaign in operation from February 24 to March 19. Further telephone efforts are reportedly being directed at recruiting and training volunteers for getting voters to the polls on election day. Two newsletters have been sent, but supposedly only to volunteers already active in the Reagan campaign.

There have not yet been any direct mail efforts although a mailer is scheduled to be received by identified Reagan supporters the day before the primary. There has also been no radio or television advertising to date, however, the Reagan organization has recently inquired about the availability of time for the two week period preceding the April 6 primary.

In short, the Reagan campaign in Wisconsin has been scaled down considerable from the effort pursued in the earlier primary states.

SURVEY RESEARCH

Market Opinion Research conducted an indepth survey of Wisconsin for the PFC from January 29 to February 2, 1976. Major excerpts are provided below.

Issues

Economic problems are the chief concerns of Wisconsin Republicans. Inflation, unemployment, and the economy in general lead their list of the most important problems facing the country. Of particular note in the state contest is the concern over high taxes. (25%)

Crime, the energy crisis, and government spending worries are less in evidence in this state with each being mentioned by less than 10% of the voters both in the national and the state context.


Reagan Candidacy

Although familiarity with Reagan does have an important impact on voting intentions, (Reagan is 21 points stronger among those who report knowing "a great deal" or "a moderate amount" about him compared to the Republicans who know "very little" about him), perceptions of the President's job performance exert the greatest influence by far. For example, the President's ballot strength for matched groups on their knowledge of Reagan is an average 64 points greater for those who approve of his job performance over those who disapprove. In short, Reagan will make some gains in Wisconsin as he campaigns there, but he will not be able to overtake the President unless there is a significant increase in Republican dissatisfaction with the President.

The race is somewhat tighter among Republicans in the City of Milwaukee with the President's lead dropping to sixteen points (55% to 39%). The President is very strong in the remaining areas of the state, including Dane County and the Madison media market, the counties between Milwaukee and Chicago, and most of the outside area including the Green Bay media market.

The President's dip in strength among Milwaukee Republicans has added significance because this group reports a much larger potential for going to the polls. Fifty-seven percent (57%) of the Milwaukee Republicans say they will "definitely" vote compared to 45% of the non-Milwaukee Republicans. The "definite voters" are particularly less frequent in the Green Bay area (35%).

Elmore Airplane Matter

Priscilla Hobson of the PFC office in Los Angeles informed me that certain arrangements concerning the use of a private airplane to transport a PFC speaker from El Centro, California to other scenic spots were being made by a Mr. John Elmore.

Our inquiries concerning the ownership of the airplane resulted in information that title to the craft was not held by Mr. Elmore personally but by a corporation — the Elmore Company. We thereupon advised Elmore that we could not accept use of the plane gratis, and that the corporation would have to be reimbursed for any expenses connected with PFC use. The alternative means of reimbursement suggested were: (1) Rental of the plane from the corporation by Elmore (who then could, if he wished, treat the rental costs as a donation to the PFC); or (2) Direct reimbursement to the corporation by the PFC.



The latter alternative was chosen at the recommendation of Leon Parma. To facilitate that recommendation, I spoke to a Mr. Vic Anderson who, I am informed, is responsible for travel arrangements at the Elmore Company. Anderson indicated that the corporation had a standard procedure for charging costs to any person using the company airplane for other than business purposes. The rate charged to all such users is \$40 per hour plus fuel costs. Because this billing procedure is applied on a uniform basis, it appears to constitute a fair and proper means of computing the costs of use on behalf of the PFC. I therefore asked Anderson to write a letter to the PFC stating that Elmore's standard charges would be billed to the PFC; Anderson agreed to write such a letter prior to actual use of the plane.

ADVISORY OPINIONS

The Federal Election Commission announces the publication today of Advisory Opinions 1975-91, 1975-94, 1975-104, 1975-108, 1975-124, and 1975-129. The Commission's opinions are in response to questions raised by individuals holding Federal office, candidates for Federal office and political committees, with respect to whether any specific transaction or activity by such individual. candidate, or political committee would constitute a violation of the Federal Election Campaign Act of 1971, as amended. of Chapters 95 or 96 of Title 26, United States Code, or of Sections 608, 610, 611, 613, 614, 615, 616, or 617 of Title 18 United States Code.

The Advisory Opinions which follow were approved by the Commission at its regular meeting of January 29, 1976. which was prior to the rendering of the Supreme Court decision in "Buckley v Valeo" on January 30, 1976. The opinions are published as approved by the Commission although it should be noted that any holding in any opinion that relates to 18 U.S.C. 608(a), 608(c) or 608(e) is modified by the Supreme Court decision which held those sections to be invalid under the First Amendment. However, section 608(c) was held to be applicable to presidential candidates eligible and applying for public funds under Chapters 95 or 96 of the Internal Revenue Code, Title 26, U.S. Code.

ADVISORY OPINION 1975-91

EXPENDITURES BY THE DEMOCRATIC NATIONAL COMMITTEE AND OTHER POLITICAL COMMITTEES TO DEFRAY EXPENSES OF DELEGATES AND ALTERNATES TO THE PRESIDENTIAL NOMINATING CONVENTION

This advisory opinion is issued under 2 U.S.C. 437f in response to a request submitted by Sheldon Cohen on behalf of the Democratic National Committee (DNC) which was published as AOR 1975–91 in the November 4, 1975, Federal Register (40 FR 51356). Interested parties were given an opportunity to submit written comments relating to the request.

The DNC wishes to know under what circumstances could expenses of delegates and alternates participating in the presidential nominating convention be defrayed by either the DNC or state and local party committees without violating 26 U.S.C. 9008. On January 15, 1976, the Commission adopted the proposed regulation on convention financing for transmittal to Congress. The conclusions reached in this advisory opinion are based upon the provisions in that proposed regulations.

The statute provides that the DNC may not defray the expenses of delegates and candidates with public funds (26 U.S.C. 9008(c)). However, the DNC may use public funds to defray the expenses of a person who is participating at the convention in the capacity of official con-

vention personnel of the national party, even though that person is simultaneously a delegate or candidate to the convention. Otherwise, delegate and candidate expenses may be defrayed by the DNC with private funds, but the amount of the private funds so expended will count toward the party's \$2 million expenditure limitation and entitlement. See § 120.2(e) (11) of the proposed regulation. For example, if the DNC spends \$250,000 for delegate expenses from private funds, its entitlement to public funds and the amount the DNC may spend for other convention expenses will be reduced by that amount to \$1.750,000. If, however, the state or local party committees wish to defray the expenses of delegates to the convention, those expenditures are not only permissible, but also they will not be considered to be expenditures made by the national party under 26 U.S.C. § 9008(d)(1), and thus not counted toward the national party's expenditure limitation or against its entitlement. See § 121.5. The Commission points out that Convention expenditures of 26 U.S.C. § 9008 are separate from expenditures under 18 U.S.C. § 608. Consequently, the reporting requirements and expenditure limitations applicable to delegate-candidates outlined in Advisory Opinion 1975-12 remain intact (40 FR 55596, Nov. 28, 1975).

Finally, the DNC suggests that they could receive their full entitlement and still defray the expenses of delegates with additional private funds if the Commission allows them the exception provided in 26 U.S.C. 9008(d)(3). The only way that a national party may spend more than its limit, whether or not the party accepts all, part, or none of its public fund entitlements, is if the Commission determines under section 9008(d)(3) that the extra expenditures are "due to extraordinary and unforeseen circumstances." Congressional intent indicates that such exceptions would be made "only in cases in which events of a catastrophic nature overwhelmingly imperil the operation of a presidential nominating convention". H. Rept. 1239, 93d Cong., 2d Sess. 34 (1974)

Based on this statutory language and history, the Commission does not at this time consider the impecunious status of delegates to fall within the exception of being "unforeseen" or "catastrophic".

Finally, the Commission is of the opinion that any reference in this advisory opinion to "delegates" is equally applicable to alternates.

This advisory opinion is issued on an interim basis pending final promulgation by the Commission of rules and regulations or policy statements of general applicability.

ADVISORY OPINION 1975-94

PAYMENT BY CANDIDATE OF OUT-OF-POCKET COSTS OF SERVICES PROVIDED BY COR-PORATION

This advisory opinion is issued pursuant to 2 U.S.C. 437f in response to a request by Donald E. Knickrehm, Treas-

urer, Ken Pursley for Congress Committee. The request was published in the November 4, 1975, FEDERAL REGISTER (/ FR 51357), and interested parties well-given an opportunity to submit written comments pertaining to the request. No comments were received.

The requesting party seeks an advisory opinion indicating:

1. Whether a corporation which owns a restaurant may legally allow a candidate to hold a cocktail party or dinner at the restaurant if the candidate pays the actual costs of such cocktail party or dinner:

2. Whether a corporation may legally lend to or provide for the use of candidates or their committees equipment such as typewriters, copying equipment and airplanes, where the candidate or committee pays only the cost of operating such equipment and whether such transactions would constitute contributions if made by persons other than corporations and:

3. Whether the performance of campaign work by an employee of a corporation during normal working hours would constitute a prohibited contribution by

such corporation.

In response to the first question, the Commission's opinion is that a corporation which owns a restaurant may legally allow a candidate to hold a cocktail party or dinner at its restaurant but could provide the restaurant facilities and food and beverages therein only at normal comparable charges. However, under 18 U.S.C. 591(e)(5) discounts from the charges for food and beverages not e ceeding a cumulative value of \$500 p candidate per election may be given so long as the food and beverage are provided at a charge at least equal to cost. The Commission would regard as cost the normal comparable charge for the food and beverage less the vendor's profit. Since 18 U.S.C. 610 generally prohibits corporations from making contributions, the restaurant may give the described discounts only to the extent of a cumulative value of \$500 for each election and each candidate to whom the food and beverages are sold. The candidate must report all payments for food and beverages under 2 U.S.C. 434.

With regard to the second question raised in the request, the Commission would advise that the provision to the candidate of the use of equipment such as typewriters, copying equipment and airplanes, at cost would constitute an inkind contribution. The term "contribution" is defined in 2 U.S.C. 431(e) (1) and 18 U.S.C. 591(e)(1) as " * * a gift, subscription, loan, advance, or deposit of money or anything of value (emphasis added). Since the equipment described in the request clearly has value over and above the cost of operating such equipment, the Commission would regard the use of such equipment as a contribution, unless the supplier is reimbursed for the normal and usual charge. In its proposed regulation on disclosure, adopted on November 25, 1975, the Commission stated that:


