Dear Mr. President:

I respectfully submit for your consideration the name of Nelson Rockefeller for Vice President.



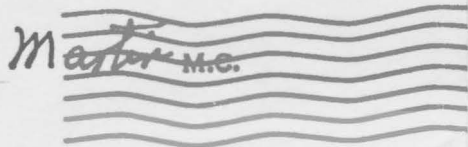
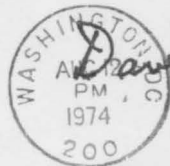

Dear Mr. President:

Regarding your request for suggestions and comments on the selection of a new Vice President, may I offer three names? All of these fit what I believe is the most important test: that the Vice President-designate have high national stature and add to the political grass roots base of support for the new Administration.

Only three Republicans under consideration excel on that test:

1. Senator Barry Goldwater
2. Governor Ronald Reagan
3. former Governor Nelson Rockefeller

Ideologically, I might rank them in that order, but other considerations argue otherwise. Senator Goldwater is needed in the Senate, too. The political situation in California is too latent to impose on Governor Reagan to leave at this time. Nelson Rockefeller is available.

Last October, in sounding out my District on this subject, I found some who would rebel at the mention of Rockefeller, but for the overwhelming most part he was acceptable to most Republicans, welcome to many, and the hope of quite a few Republicans and Democrats.

There are other names of able men and women under consideration, I know. With all due and high respect, we will have both a President and a Vice President neither of whom will have been elected to either office. Therefore, I believe it is essential that someone of the stature of the three mentioned be prevailed upon to accept this crucial responsibility.

Dear Mr. President:

On last Friday I sent you a telegram strongly recommending George Bush of Texas for nomination as Vice President. George and I were elected to the Congress for the first time as members of the 90th Club and he impressed me as one of the most effective and respected members of the House during his service there. Thereafter he performed a truly outstanding service to our country as Ambassador to the United Nations, an experience which would be invaluable for any Vice President. For the past year he has been piloting the Republican Party through one of the most difficult periods in its history. I know you are fully familiar with George's many achievements but I have listed some of them above in support of my belief that he would make an outstanding Vice President.

I am informed consideration is also being given to selecting the nominee from the ranks of the nation's Governors. If so, I would heartily recommend the Honorable Robert D. 


In the light of your succession as President of the United States, it now becomes your prerogative to nominate a new Vice President.







Dear Mr. President:

In the demanding task of selecting a Vice President, you are not in the enviable position of your predecessor, for there is no Jerry Ford for you to name.

Just as the former President did not make his selection from the ever-present crop of self-esteemed potential Presidential candidates of the Senate, so I hope that you do likewise.

Many expect you to look outside the Congress for your nominee. In my own conservative Republican district, one man is mentioned before all others, and the degree and breadth of support has surprised even me. That man is my former Governor, Nelson Rockefeller.

His character, experience and ability should commend him to you, and I am sure they do. Having said that, I must recognize, however, as I am sure you already have, that there are a substantial number of our Southern and/or Conservative friends, and those who so violently differ with his position and action as Governor on the abortion issue, who do not view with my enthusiasm the prospect of Nelson Rockefeller being their Vice President.

This brings me to believe that your search might well come back to the place from whence you came -- the People's House, but as I said in my very first sentence, "there is no Jerry Ford for you to name."

Able members we have, but not one that stands out, as did you, from and above all of the rest. Some I would suggest are too positively identified as Conservative or Liberal, too young or too old, or for geographic or other reasons might be better not considered.

There is one member that I believe meets every test.

First and foremost, he is a man in whom you have trust and confidence. By his intellect, unquestioned character, warm personality, age and strong physique, he is, like yourself, well endowed for whatever might be asked of him.

He is a conservative who was asked to join, and did join, the liberal Wednesday Club. His grasp and understanding of economic problems are sure and strong. He is an Easterner as much as the Ivy League college and law school from which he graduated, but he is as American as apple pie and the Marine Corps in which he served in two wars. What is most essential, he would pass the close examination to which his nomination would be subjected -- an examination which you so successfully met and passed.

If you were to nominate him, millions of our fellow citizens would ask "Barber who?", but not one voice could raise a valid criticism or objection to his qualifications. He would articulate, for articulate he is, your Administration's actions and aspirations and accomplishments. He would become known, and as America came to know him, they would share the same wonderful experience that you and I and his colleagues and the people of his own district have enjoyed. He would continue to grow in stature and in the affection of the people.

The great strength of America is its people. Like you, Barber would come not from the list of the potential candidates and the "greats" but from the people. As the boy on the elevator said this morning, "Isn't it marvelous about Mr. Ford, he was just one of the people in the House." I have every confidence that he, like you, has what would make him great when greatness is to be witnessed by more than intimate friends and associates.

If your immediate need was for popularity and acclaim, I would not suggest a relatively obscure man of Congress, but you have that immediate popularity and acclaim from your wonderful speech in accepting the Presidency and the warm reception and enthusiastic response given this past evening to you and your address.

I must conclude that you have my assurance of support and respect for your judgment in whomever you may nominate-- my former Governor, our dear friend, Barber, or whomsoever you may select.
