Dear Mr. McCloskey...

In response to your March 15th letter to Alaska's Senator Stevens, it appears that you have failed to evaluate the real purpose and perspective projection of the ARCTIC COUNTRIES MUTUAL INTEREST EXCHANGE CONFERENCE due, in part, perhaps to the lack of explanation.

To reiterate Mr. Charles Robinson, Undersecretary of State for Economic Affairs who, at the global economic talks that convened in Paris December 16th past, based his reasoning on this valuation.... "The United States views this preparatory conference as an essential step in search for a new global consensus based on cooperation. We accept the reality of economic interdependence and recognize that what diminishes the economic success of the developing nations diminishes our own"...

Our endeavors are, however, merely projecting the basic philosophy of the United States in recognizing that the economic success of the arctic countries has a pronounced bearing on our very own success. Interdependence among the arctic nations is the valued projection on which this proposed gathering is based.

The visionary resolution as adopted by the Alaska State Legislature in its broad agenda matters may appear to be over ambitious with workshops, colloquies and programs. The intention was not designed for the initial purpose but of resulting future possibilities. Rather a preparatory, an introduction if you will of the arctic nation perspectives that could offer the greatest unity of purpose based on economic realities of cooperation. And since the arctic constitutes - a major source of raw materials - the subject of economic industrial development is of prime importance.

In my October 17, 1975 letter to Mr. Robinson on learning that the Commission on Raw Materials and Industrial Development planned to meet elsewhere other than in Paris, I proposed an Alaska meeting because of the merits of the arctic resources. This is consistent with my 25 years of Alaska international vision.... A summit conference proposal as chairman of the international affairs for the city; as mayor, a congressional bill by the former Senator Gruening to establish a international reception and industrial information center at the airport; as borough assemblyman an adopted state legislature resolution to establish an arctic economic commission in the United Nations.

To accomplish this awakening reality, in the birthday year of America, the State Department has, by experience from the global economic conference in Paris, the knowledge, functional facts and learned results to share some of these essentials and to reshape some of these major importances applicable to the arctic conference. The findings of the Commission on Raw Materials and Industrial Development is of worthy economic value in furthering the perspective of the arctic.

Alaska holds a prestigious place in the hearts and minds of its arctic neighbors as related by but one enthusiastic Sweden.... "As we think your idea of a meeting in Alaska is very interesting, we are looking forward to an invitation from the State of Alaska"...

Therefore, let us look to the United States as the leader and through the State Department invite and program the conference based on values gained and shared moving toward a cooperative economic step of interdependence among the arctic nations. For it is better to have dreams like Thomas Jefferson, Abe Lincoln and Martin Luther King.... Dreams of a better tomorrow. Perhaps, the best we as Americans can do in our Bicentennial is to dream of what we want to be able to celebrate five or ten years from now and indicate ourselves to fulfilling the necessary steps. By taking the initiative in Alaska, we are extending the horizon both at home and abroad.

A RESOLUTION SUPPORTING HOUSE JOINT RESOLUTION NO. 51

WHEREAS, House Joint Resolution NO. 51 proposes an Arctic Country Mutual Interest Exchange Conference to be held in Anchorage, Alaska, during 1976; and

WHEREAS, Anchorage is critically interested in an exchange of information, opinions and solutions to issues and dilemmas facing the Arctic nations (Canada, Iceland, Norway, Sweden, Finland, Denmark, the Union of Soviet Socialist Republics, and the United States of America); and

WHEREAS, the proposed Arctic Country Mutual Interest Exchange Conference is an attempt to establish a formal mechanism by which the Arctic nations may meet periodically to exchange ideas on common issues and problems;

NOW, THEREFORE, the Assembly of Anchorage resolves:

Section 1. That the Anchorage Assembly supports the proposed Conference and requests the Alaska Congressional delegation to make the appropriate representations to the President and Secretary of State to effect initiation of an Arctic Country Mutual Interest Exchange Conference.



Section 2. That the Municipality of Anchorage would enthusiastically assist the Governor of Alaska and his administration to work for the successful culmination of the proposed first Conference during our Bicentennial Year.



I have been asked to reply to your letter of April 5 to Assistant Secretary Robert J. McCloskey regarding an Arctic Country Mutual Interest Exchange Conference in 1976 proposed in Joint Resolution 51 recently passed by the Alaska State Legislature.

The Assistant Secretary's letter of March 15 to Senator Stevens, a copy of which you have, conveys the considered opinion of the Department on the feasibility of a conference such as that described in the Resolution. Your letter of April 5 suggests a much more modest international gathering of a planning nature. A preparatory meeting that would deal with the realities of such a demanding and complicated undertaking as that outlined in the Resolution would seem to be an essential early step.


The State of Alaska is, of course, at liberty to sponsor an international conference on the subjects it proposes, on a scale it desires, and at a time of its choosing. For our part, it would be virtually impossible to do more than offer advice and encouragement. Given the nature of the federal budget cycle, and the obligations already incurred, possible funding by the Department of State for an Arctic Country Mutual Interest Exchange Conference

could not have been anticipated for this or the next fiscal year. However, the Department would be prepared to transmit through its facilities abroad any invitations by the State of Alaska to intended participants in such a conference as Alaska decides to hold.
