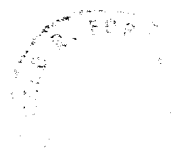

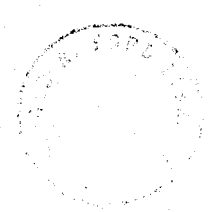

### BIOGRAPHY OF TOM HAGEDORN GOP CANDIDATE FOR CONGRESS 2ND DISTRICT, MINNESOTA

Tom Hagedorn, 30, was born in Blue Earth, Minn., attended public schools, and became a grain and livestock farmer in Truman, Minn., his present home. He also operates a commercial crop drying firm.

He is now serving his second term in the Minnesota Legislature, having been first elected in 1970. Hagedorn also is active in the Minnesota Crop Improvement Association, the Minnesota Farm Bureau Federation and was a member of the Minnesota GOP Platform Committee in 1972. He is a winner of the Truman Jaycee's Distinguished Service Award.

Hagedorn is married to the former Kathy Middlestadt, and the couple has three children, James, 12; Heidi, 11, and Tricia, 3.

The Hagedorns are members of St. Paul's Lutheran Church of Truman. He won the Congressional seat formerly held by GOP Rep. Ancher Nelsen, who retired.

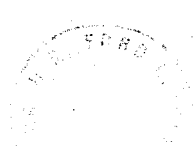
George V. Hansen, [REDACTED] Pocatello Businessman has a broad background of achievement in Government, private enterprise and public education.

Mr. Hansen has 7 years of high-level experience in the Federal Government, first as a Member of Congress and then with the U. S. Department of Agriculture as Deputy Under Secretary and National Administrator of State and County Operations. Born and educated in Idaho, his college work includes a Bachelor's Degree (Honors) in history and Russian and graduate work in education. He is also a business college graduate in accounting and management, and holds certificates of completion for professional and executive training courses in government and private enterprise. He served in the U. S. Air Force and as a Naval Reserve Officer and has taught high school science and mathematics. His business experience includes agriculture, insurance, and retail merchandising.

Mr. Hansen was elected in 1964 to the 89th Congress from Idaho's Second Congressional District against the tide of a Presidential landslide, and re-elected by a record margin to the 90th Congress in 1966. In 1968 he conducted a strong, but unsuccessful campaign for election to the U. S. Senate; which was one of the Nation's featured races. As a Member of Congress he served on two major Committees--Agriculture and Interior and Insular Affairs--and gained wide recognition for his leadership, effectiveness and public speaking.

Mr. Hansen joined the Department of Agriculture in January 1969 as Deputy Under Secretary where he organized Congressional Liaison services for the new Administration. In March of that year he was appointed to head the Agricultural Stabilization and Conservation Service's extensive State and County operations responsible for nationwide administration of Federal farm programs through some 3,000 offices in 50 States and Puerto Rico. He also served as a Deputy Vice President of the Commodity Credit Corporation.

Prior to his Congressional Service, Mr. Hansen had been elected as Mayor of Idaho's ninth largest city--the youngest municipal executive in the State--and twice elected as a City Commissioner for what was then the State's largest city. Mr. Hansen earned recognition for progressive actions as a municipal official. He became known as "Alameda's Miracle Mayor" and in 1961 during his term of office, this city was named "Idaho City of the Year." In 1962, he initiated and helped lead the successful merger of two of Idaho's major cities, Alameda and Pocatello, to form the largest city in the State. In 1963, with Mr. Hansen serving on the combined Board of Commissioners as Vice Chairman, the new city of Pocatello also achieved the "Idaho City of the Year" award and honorable mention as "All America City." During this same period, as a member of the Board of Directors of the Idaho Municipal League, he initiated reforms which turned the problem-ridden State association of city governments into a reputable and effective organization.

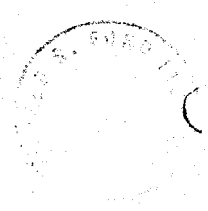


Among honors, Mr. Hansen has received, are the U. S. Department of Agriculture Certificate of Merit for Outstanding Performance (1971), the Distinguished Alumnus Award from Ricks College, Rexburg, Idaho (1969), Distinguished Service Awards from the Young Republican National Federation (1968), National Associated Businessmen (1966 and 1968), American War Mothers (1967), Americans for Constitutional Action (1966), National Association of Life Underwriters (1966), National Right to Work Committee (1966), League of Idaho Cities (1963), Pocatello Jaycees (1961), and numerous business achievement awards. He is a charter member of the association of Former Members of Congress and served on the first official nominating committee. He is listed in the Biographical Directory of the American Congress, The Blue Book, Who's Who in America, Who's Who in American Politics, Who's Who in Government, Who's Who in the West, and Personalities of the South.

Mr. Hansen has been active in business, professional, service, farm, school, church, veteran, community and political organizations. His wife, the former Constance Sue Camp of Paragould, Arkansas, is listed in "Who's Who in American Women" and was named one of the "Outstanding Young Women of America" in 1968. She has served as Vice-Chairman of Bannock County Republican Central Committee, Pocatello, 1963-64; PTA President, 1964; President of the American Legion Auxiliary, Pocatello, 1963-64; and President of the Ladies Auxiliary of the Idaho Municipal League, 1963-64, responsible for selecting the "City of the Year". She was named "Mrs. Pocatello" and selected first runner-up and "Mrs. Congeniality" in "Mrs. Idaho" (for Mrs. America) contest, 1958.

Mrs. Hansen has been employed as Receptionist and Staff Assistant with the National Republican Congressional Committee for two years and in other retail, secretarial and telephone positions. She has served many years in leadership and teaching capacities in church, service and professional organizations including Red Cross, Cancer Society, American Legion Auxiliary, and Washington, D.
