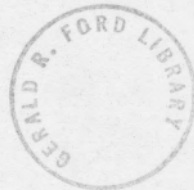

Attached is the background information for Missouri from Rep. Gene Taylor.

BACKGROUND INFORMATION ON MISSOURI FROM REP. GENE TAYLOR

The following information on Missouri was supplied by Rep. Gene Taylor for the President's Friday, June 11, visit to Springfield.

The major issues of concern are:

1. The Budget - deficit spending - how the growth of the bureaucracy and federal programs have contributed to this deficit - how the President's vetoes have saved the public millions of dollars.
2. This is the fourth largest cattle raising state in the nation. Because of the size of the ranches, they are concerned about estate taxes.
3. They are opposed to gun control and support the President's position for mandatory sentencing.
4. The Congressman's mail is heavy on the Panama Canal issue (opposed to negotiating it away) and anti-Kissinger.
5. They support reform of regulatory agencies.

BACKGROUND INFORMATION ON THE PRESIDENT'S TRIP  
TO MINNESOTA CALLED IN BY REP. TOM HAGEDORN

1. Suggests the President play on the economy because Minnesota has not suffered as much as the rest of the country. He said the talk should center on the economic recovery and renewed confidence.
2. The President should bring out how he has restored integrity to the office of the President considering the difficult time when he took over.
3. Agriculture and related foreign sales of agriculture products.
4. Estate tax reform - suggests criticism of Ullman position
5. Mention drought conditions in the midwest, especially Minnesota. (Mr. Hagedorn mentioned a helicopter review by the President of the drought situation in the 2nd and 6th districts after the planned events in Minnesota. He would be happy to accompany the President and also suggests inviting the 6th district Republican candidate.)

BACKGROUND INFORMATION ON THE PRESIDENT'S TRIP  
TO COLORADO FROM REPS. ARMSTRONG AND JOHNSON

1. Energy development - while there is some sentiment against the synthetic fuel bill now making its way through the House, people of the state favor the development of oil shale and coal. Also, they support deregulation of natural gas.
2. All environmental issues are of great concern in this state.
3. There is a flap over a bill now in conference to create an Eagles Nest Wilderness Area. While the wilderness area legislation is supported in the state, it is claimed by the people in Denver that the House version of the bill would reduce the water supply to the Denver area. Large ads are being taken out in newspapers claiming that the federal government is doing the people in again. It is suspected that the true backers of this ad are members of the Denver Water Board who are prominent conservative Republicans.
4. Farm issues are important, especially those relating to grain exports.



BACKGROUND INFORMATION ON THE PRESIDENT'S TRIP  
TO MINNESOTA BY REP. AL QUIE

- The President should stress the differences between Republican proposals in the Congress and those offered by Democrats.
- Stress that the Republican programs such as revenue sharing retain the freedom of decision-making at the local level.
- Besides revenue sharing, other issues such as adequate defense, operating the government in the open (sunshine law), the President's program to help people without putting them on welfare.
- The economy of Minnesota is agricultural. They are concerned about any embargoes on agricultural products and the problem of reduced crops this year because of the drought. Secretary Butz has been asked to send someone out to view the drought conditions and if this has not been done and if the rains have not arrived by the time the President arrives, he should be prepared to announce some sort of action.

MAJOR ISSUES IN THE STATE OF IOWA FROM CONGRESSMAN  
CHARLES GRASSLEY

Estate tax reform is undoubtedly the biggest issue facing the rural areas. We would recommend that the President not get too specific in that his plan is not the most popular.

We would suggest a further pledge in his opposition to grain export controls.

He might stress that the Administration is working to expand our foreign agricultural markets.

Food stamp reform, both legislatively and especially the regulations that the Department of Agriculture is trying to implement.

The Common Situs Picketing bill was a big issue and he might want to make some mention of the fact that Iowa is a "Right to Work State".

If he is going to be talking about the Congressman, we would like to call light to the fact that Mr. Grassley is one of the very few members that has a perfect 100% voting and attendance record. Congressman Grassley feels that the key in this year's election is going to be the elderly and Mr. Grassley is on the Select Committee on Aging. The President in March signed into law a bill cosponsored by the Congressman which prohibited discrimination in the granting of credit on the basis of age (HR-6516).

MAJOR ISSUES IN THE STATE OF CONNECTICUT FROM  
CONGRESSMAN RON SARASIN

\*1. Unemployment

Percentage of unemployment in the 5th Congressional District ranges from 11-1/2 to 14%. For example, Waterbury, 11-1/2% and Naugatuck Valley - Approximately 14%.

2. Economy

Assistance for heavy industry.

3. Support for Revenue Sharing.

4. Tax Reform

Not only for the individual taxpayer, but assistance to private industry to help encourage more employment. (Investment tax credit, a labor tax credit, etc.)

5. Energy

\* In terms of the one that would have the most priority.

MAJOR ISSUES IN THE STATE OF CONNECTICUT FROM  
CONGRESSMAN STEWART MCKINNEY

1. Jobs

Rate of Unemployment - April  
Nation - 7.3  
Connecticut - 9.6  
Bridgeport - 11.2  
Bristol - 13.3  
Waterbury - 11.1  
New Haven - 10.1

McKinney voted to override the veto of the Jobs bill.

Suggestion - In the Housing and Community Development Authorization Act a countercyclical employment provision was included in the House bill, but not the Senate version. If accepted by the conferees this would mean 1.2 billion would be pumped into areas with high unemployment for urban redevelopment. Approximately 3 million for the City of Bridgeport. Perhaps the President could expand his support for this concept of tying public jobs to revitalizing older urban areas.

2. Youth Unemployment

Very bleak for recent high school and college graduates. Both parents and young people most receptive to Presidential initiative.

Suggestion - program for incentives to business to hire and train young people.

3. Inflation

Need to counter reoccurrence of doomsday economic forecasting for which New England is particularly susceptible since the economic upswing affecting the rest of the country has yet to arrive in New England. Stress that the President has fought to successfully lower inflation and that inflation is a hidden tax.

#### 4. Energy

The need for energy independence is acutely felt in the Northeast. McKinney is supporting the \$ 2 billion loan guarantee program for private industries development of alternate fuel sources.

5. Connecticut has been the second largest producer of war materials in the last two wars and there is great bitterness that we are losing employees to the South. Pratt and Whitney has just announced the relocation of 2,000 employees to Florida. While it would be most advantageous if a contract such as the Uttas could be awarded to Connecticut firms. It is probably equally important that efforts be made to reorientate the economy of New England towards peacetime productivity. i. e. instead of tanks, trains.

#### Question

Why does the President keep vetoing bills that would help the cities? McKinney's answer is "I don't blame the President because while these bills start out as decent proposals they end up being pork barreled to such an extent that they leave the President with no choice but to veto them."

BACKGROUND INFORMATION FROM REP. TRENT LOTT FOR  
CONSIDERATION PRIOR TO THE PRESIDENT'S TRIP TO MISSISSIPPI

Believes Mississippi is now extremely fertile ground to pick up significant delegate support to the GOP convention. Even before the Reagan announcement of Schweiker as his Vice Presidential running mate Mississippi agreed with and has strongly supported the President on many of his positions.

Trent said that he has never publicly committed himself to Reagan or Ford. He is now willing to show his support for the President by going with the President to Mississippi. Lott believes the President should emphasize to the Mississippi GOP delegation and the State news media:

- 1) his strong interest in the problems and accomplishments in the South.
- 2) that he will personally work very hard to gain the support of the South in the November election.
- 3) that he will select a Vice Presidential running mate who will be acceptable to the South and who will work hard in the South during the fall campaign (recommends that the President not make any Vice Presidential commitment prior to the National Convention.)

BACKGROUND INFORMATION FROM REP. THAD COCHRAN  
FOR CONSIDERATION PRIOR TO THE PRESIDENT'S TRIP TO MISSISSIPPI

Cochran urges the President to go to Mississippi. The Congressman will be more than happy to accompany the President to Mississippi and take appropriate actions during any meetings which might be planned.

The President may wish to remind Mississippians that he visited the State as Vice President. Suggests the President recall certain appropriate events during that visit.

Cochran has been impressed by Congressman Ron Sarasin's report of the President's remarks to the Connecticut State GOP Convention. Suggests this same approach be made in Mississippi.

Vice Presidential Running Mate

Recommends that the President state that Mississippi, as well as the rest of the nation, can be assured that the President will not select any "extremist" as his Vice Presidential running mate. (But the President should not commit to anyone his Vice Presidential running mate before the GOP Convention.)

The President should be reminded that unfortunately Vice President Rockefeller is unpopular in the State of Mississippi.

Secretary Kissinger

The name of Henry Kissinger is still a "red flag" in Mississippi.

If asked about Henry Kissinger, Cochran suggests the following Presidential response:

When I took over as President there was considerable apprehension that there would be great turmoil in the direction of American foreign policy. I, therefore, felt that it was best that we continue the basic approach already in place. I will not apologize for retaining Secretary of State Kissinger. In retrospect, I am confident this was the correct decision.
