Would it be possible for Tom and Marty to come to the White House for dinner possibly Monday evening (Oct. 6) or Wednesday evening (Oct. 8). They would not be staying at the White House-- but they would like to come for dinner if at all possible. If this is all right, they will bring Cameron (now 2 yrs. old) over to the Oval Office about 6:30 just so you can see him and then they will take him over to the Residence so Mrs. Ford can see him and then someone will pick Cameron up and take him back to the Hotel. Tom and Marty would then stay for dinner.
