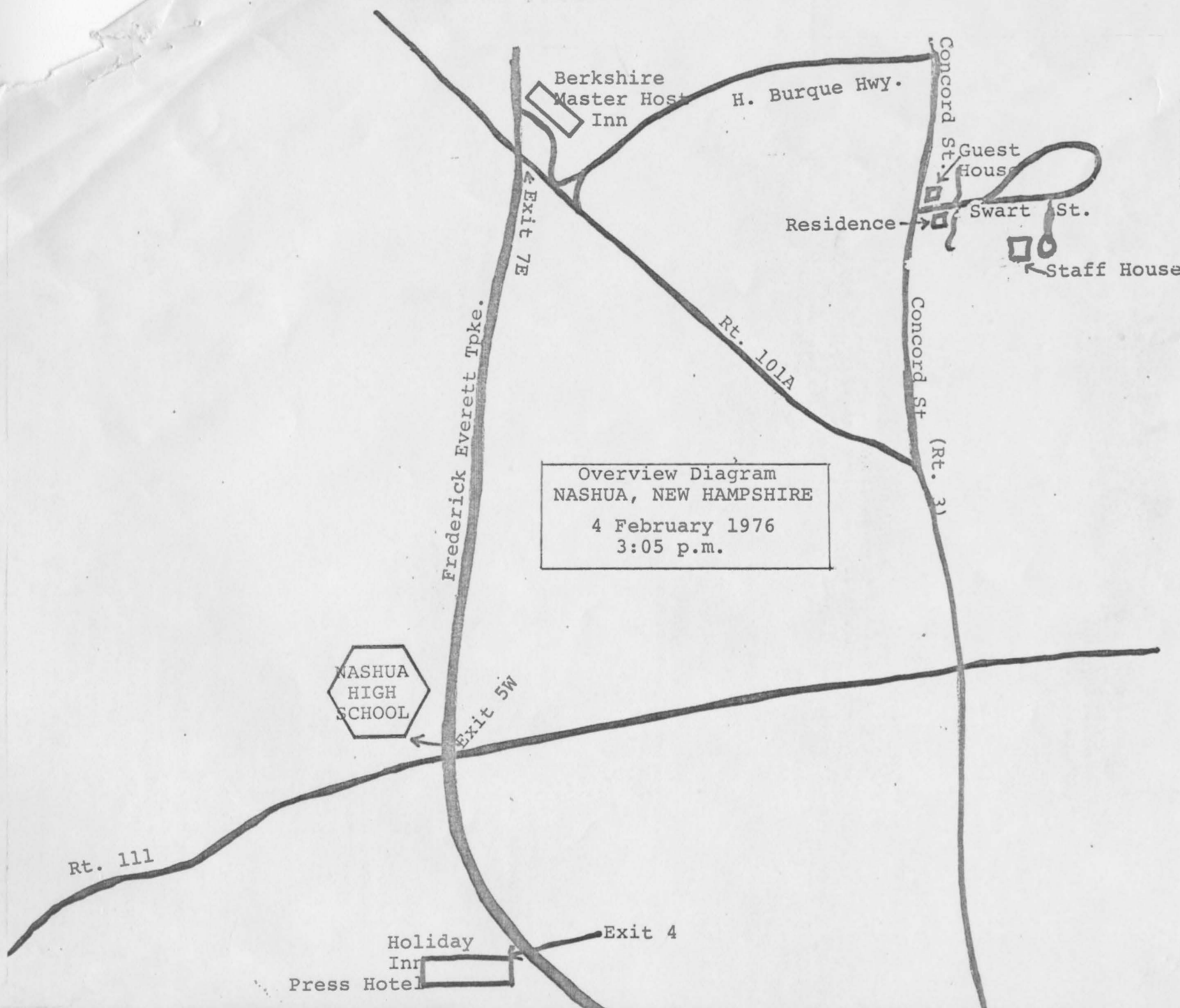

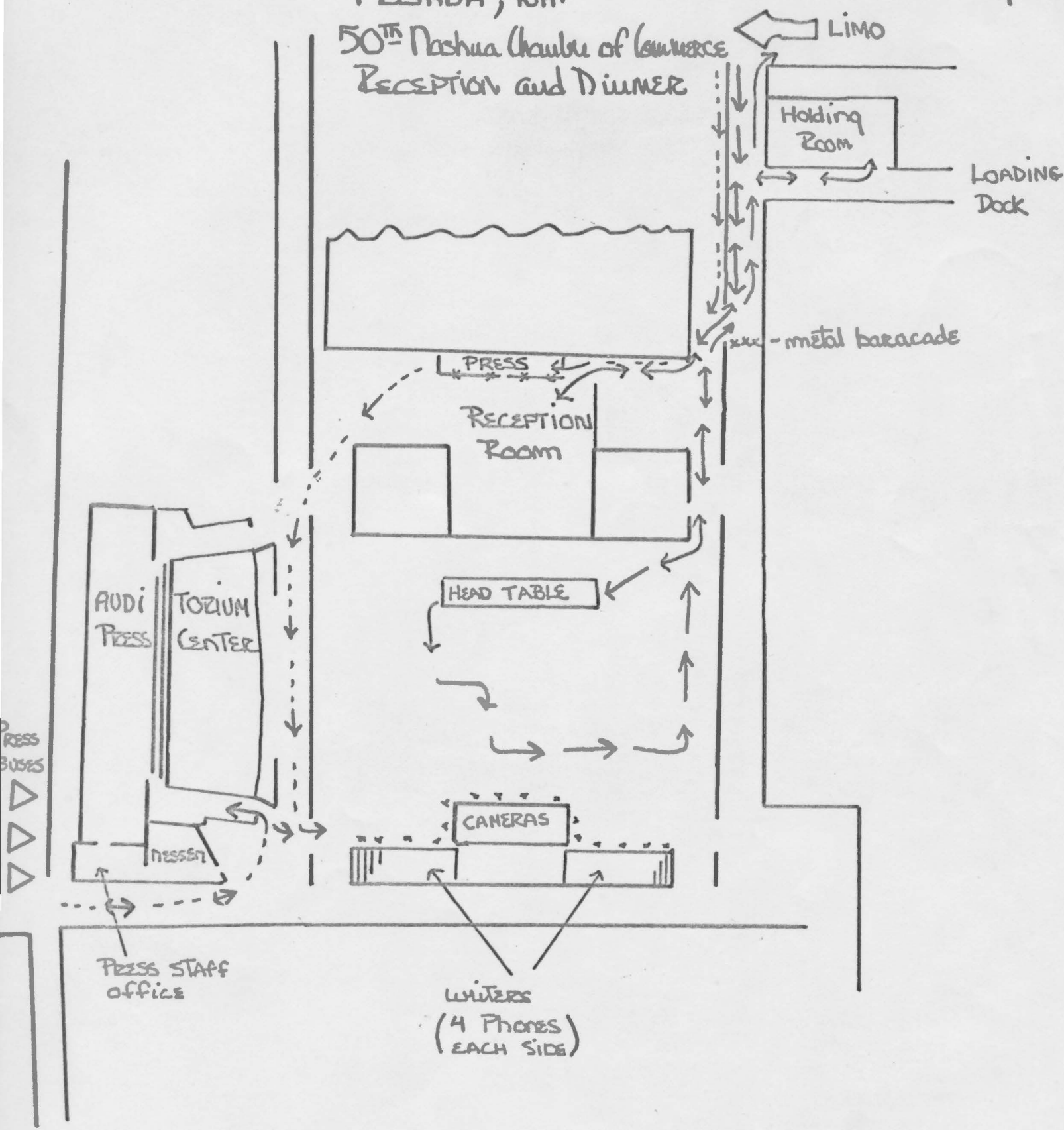
Plan Lower Unit "F"



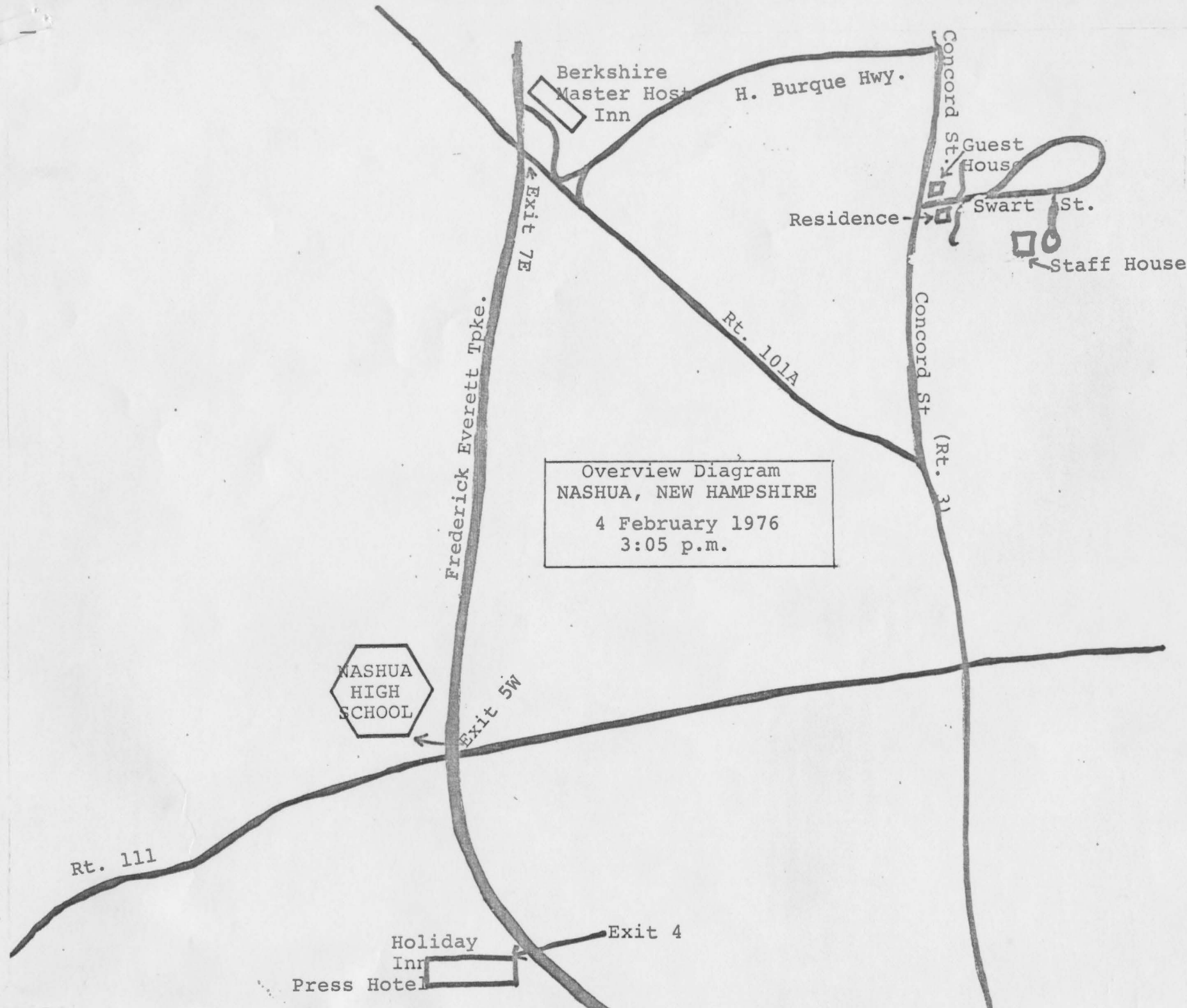
