FOR THE PRESIDENT

1. Food Stamps

Dick Dunham, Earl Butz, and Paul O'Neill have been working on Food Stamp abuses and reform proposals. We will have an options paper for your review and decision next week.

2. Social Security Financing

Cap Weinberger sent his recommendations on short- and long-range financing Social Security issues over last Friday. We are reviewing them with OMB and others and plan to meet with Cap when he returns from Australia. Cap is scheduled to testify before the Ways and Means Committee on May 20 and we hope to have the short-range financing decisions worked out by then. We will get you a decision paper on this issue no later than next Thursday, May 15. The long-range financing proposals will not be ready until late Fall.

3. Strip Mining

We are working with Frank Zarb, OMB, Jack Marsh and others on a decision paper and will have it to you by tomorrow night.

4. Title 9 - Regulations Preventing Sex Discrimination in Educational Institutions

We have Cap Weinberger's proposed regulations on this as well as the recommendations of other key agencies involved. Our staff has been reviewing the HEW proposals and we will have a paper for your review next Monday, May 12. The Congress has passed legislation requiring that the regulations be put before the Congress for 45 days before they become effective. We have been operating under a July 1 target date which would mean that the regulations should be transmitted to the Congress by May 15.

5. Crime Message

MEMORANDUM FOR THE PRESIDENT

FROM: JIM CANNON

You asked for a list of those areas for which the Domestic Council is planning to recommend review groups. This is an interim report to indicate where we are right now.

The Vice President and I agree that these are the areas in which we should begin immediately:

1. Energy and Resource Policy and Finance

Approved by the President last Friday, May 2, 1975.

2. Federal Social Programs

Has been submitted to the President and is still under consideration.

3. Government Regulations

This proposal would encompass a comprehensive study of Federal, State, and local economic, and social regulation with emphasis on how government regulation and government interference affects private enterprise and the individual.

Rod Hills has been working with us on this. Since the environmental review group, which you already approved, is primarily concerned with regulation, we feel it should be subsumed in an overall review group on regulation.

4. The Federal Drug Abuse Review Group

This was approved on 4/24/75 and now is being implemented. A memorandum will go out this week asking that each member of the Review Group assign a representative for the work.

The Vice President has suggested a meeting of the Domestic Council to review their proposals. Out of this may come additional proposals for your consideration.

MEMORANDUM FOR THE PRESIDENT

FROM: JIM CANNON

You asked for a list of those areas for which the Domestic Council is planning to recommend review groups. This is an interim report to indicate where we are right now.

The Vice President and I agree that these are the areas in which we should begin immediately:

1. Energy and Resource Policy and Finance

Approved by the President last Friday, May 2, 1975.

2. Federal Social Programs

Has been submitted to the President and is still under consideration.

3. Government Regulations

This proposal would encompass a comprehensive study of Federal, State, and local economic, and social regulation with emphasis on how government regulation and government interference affects private enterprise and the individual.

Rod Hills has been working with us on this. Since the environmental review group, which you already approved, is primarily concerned with regulation, we feel it should be subsumed in an overall review group on regulation.

4. The Federal Drug Abuse Review Group

This was approved on 4/24/75 and now is being implemented. A memorandum will go out this week asking that each member of the Review Group assign a representative for the work.

The Vice President has suggested a meeting of the Domestic Council to review their proposals. Out of this may come additional proposals for your consideration.
