BACKGROUND

1. WHITE HOUSE CONFERENCE ON DOMESTIC AND ECONOMIC AFFAIRS

The White House Conference on Domestic and Economic Affairs in Atlanta is sponsored by the White House Office of Public Liaison and co-sponsored by 15 local and State organizations. Approximately 650 guests and a large press contingent are expected to attend.

The Conference and all related activities will take place at the Hyatt Regency Atlanta Hotel. Activities will begin on Sunday evening at 7:30 p.m. with a special dinner planned with the press and will conclude with your address Monday afternoon.

SUBJECT: Judicial Status Report

This memorandum reports upon the current status of vacancies and potential vacancies within the ranks of Federal Judges, U. S. Attorneys, and U. S. Marshals. The information presented is based upon Justice Department data and other pertinent materials at our disposal.

It should be noted that Attorney and Marshal vacancies are technical in character. To wit, the seat is rarely, if ever, physically vacant since (1) upon expiration of a term the incumbent continues to serve until a new or re-appointment is made; or (2) upon the death or resignation of an incumbent, the court usually appoints an individual to serve until a Presidential appointment is made. Consequently, the existence of a vacancy does not suggest that the job is unattended as is the case with vacancies on a bench.

FEDERAL JUDGES

Within the U. S. and its Territories there are 523 Federal Judges all of which, with the exception of those seats in the Territories and the District of Columbia are Life Appointments earning a Level II equivalent (\$42,000 per annum). Currently, 15 are vacant, and of these 15, three (3) candidates have been announced but not yet confirmed by the Senate, and one (1) other is in clearance at the White House. Consequently, there are 11 actual vacancies (2.1%), and the following chart statistically reviews the entire Federal Judge situation:

U. S. ATTORNEYS

Within the U. S. and its Territories there are 94 U. S. Attorneys of which 15 are currently vacant. Of these 15, three (3) have been nominated but have not yet been confirmed by the Senate, and 5 others are in clearance at the White House. Consequently, there are 7 actual vacancies (7.4%); and the following chart statistically reviews the entire U. S. Attorney situation:

U.S. MARSHALS

Within the U. S. and its Territories there are 94 U. S. Marshals of which 8 are currently vacant. Of these 8, one (1) candidate has been nominated but not yet confirmed, and one (1) seat will remain vacant for several months time. Consequently, there are 6 actual vacancies (6.3%); and the following chart statistically reviews the entire U. S. Marshal situation:
