I have been giving a great deal of attention to identifying outstanding candidates to fill Governor Sheehan's seat on the Federal Reserve Board. The principal criteria I have been using in evaluating candidates are knowledge of the fields of finance and housing, managerial competence, strength of character and reputation, and broad economic understanding.

A number of outstanding men have been reviewed quietly. Some have declined to be considered, and others have been eliminated. This memorandum presents my recommendation of the leading candidate for your consideration:

Philip C. Jackson, Jr. Vice President Jackson Company Birmingham, Alabama

Mr. Jackson's age is 46. He graduated from the University of Alabama and the School of Mortgage Banking at Northwestern University. He has been associated with Jackson Company, a family-owned mortgage banking firm, since 1949, and currently serves as the company's chief operating officer.

Mr. Jackson is highly thought of in the mortgage banking community. In 1965 he was one of six mortgage bankers chosen by the Agency for International Development to study the feasibility of developing

secondary mortgage markets in Latin America. He has been active for a number of years in the management and committee work of the Mortgage Bankers Association of America. In 1965 Mr. Jackson received the Association's Distinguished Service Award as America's most outstanding mortgage banker. He served as National President of the Mortgage Bankers Association of America in 1971-72. He has been well received as a knowledgeable veteran in testimony before Congressional committees.

Besides Mr. Jackson's knowledge of mortgage banking and the housing industry, he has an excellent grasp of broader banking, financial, and economic matters. He is a first-class manager, and has a demonstrated interest in public affairs. All in all, I believe his background and qualifications make him a truly outstanding candidate for the Board at this time.
