SUBJECT: Senator Carl Curtis (R-NEB)

Although Senator Curtis may bring up some other subjects, he may mention the following recent complaints:

1. Forrest Reece - A Senate Agricultural staffer who was not named to the Commodity Futures Trading Commission, despite support by Curtis and others.
2. William Bagley, of California, who was named Chairman of the Commodity Futures Trading Commission. Curtis has been critical of this appointment.
3. Bill Walker - Senator Curtis was opposed to this nomination, but will support because of the President's personal intervention.
4. John Robson - Curtis was critical of this nomination (Civil Aeronautics Board Chairman).

Arthur H. Maslansky represented Goldstein Samuelson, Inc. as its outside counsel acquiring an expertise in commodity laws and regulations. During the course of a Securities and Exchange Commission investigation of GSI, Mr. Maslansky, with the consent of the SEC, became a required signatory on all company checks in excess of \$10,000. After a consent decree was entered into by the company and its founder Harold Goldstein in November 1972, Mr. Maslansky became President of the company and continued the financial safeguards regarding customer funds.

Immediately after assuming the presidency, Mr. Maslansky brought into the company qualified management talent in the financial and legal areas and engaged reputable outside counsel and independent auditors. He also retained the Washington D.C. economic consulting firm of Robert R. Nathan & Associates to do an in depth study on the economic viability of commodity options.

Mr. Maslansky went to Europe in January 1973 to develop an international commodity business. He spent time overseas reviewing legal and financial problems relating to such business as well as becoming acquainted with international commodity practices.

Upon returning from Europe in February 1973, he discovered that Harold Goldstein was trying to circumvent the above financial safeguards by attempting to divert over \$1,000,000 of customer funds. Mr. Maslansky halted the attempted diversions and immediately reported them to the SEC and the California Commissioner of Corporations. Mr. Maslansky then joined with the SEC in moving for and obtaining the appointment of a temporary equity receiver to conserve the assets of the company for the benefit of the public. As a result of his prompt action approximately \$8,000,000 was placed at the disposal of the receiver. Without Mr. Maslansky's cooperation and assistance, this would have been difficult to accomplish.

Mr. Goldstein plead guilty to three counts of mail fraud and was sentenced to 18 months in federal prison.

Mr. Maslansky is presently engaged in the private practice of law devoted to general corporate business with emphasis on commodity laws, taxes, securities, international finance and banking. He is extremely knowledgeable of the new California Commodity Law and the Commodity Futures Trading Commission Act of 1974.

Arthur H. Maslansky has been recommended for appointment as one of the Commissioners under the newly enacted Commodity Futures Trading Commission Act of 1974.

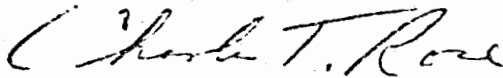
I first met Mr. Maslansky in my capacity as supervisory trial attorney with the Los Angeles Regional Office of the Securities and Exchange Commission. I personally conducted an investigation of Goldstein Samuelson, Inc., commodity option underwriters. Mr. Maslansky represented the company as its outside counsel. After a consent decree was entered into by the company and its founder Harold Goldstein, Mr. Maslansky became President of Goldstein Samuelson, Inc., and at my request he initiated certain safeguards regarding the handling of funds invested by the public.

Shortly thereafter, Mr. Maslansky discovered that Harold Goldstein was trying to circumvent these safeguards. Mr. Maslansky stopped Mr. Goldstein from diverting over \$1,000,000 of public funds and immediately reported the attempted diversions to the Securities and Exchange Commission which, together with Mr. Maslansky, moved for and obtained the appointment of a temporary receiver for Goldstein Samuelson, Inc., to conserve the assets of the company for the benefit of the public. Without Mr. Maslansky's cooperation and assistance, this would have been difficult to accomplish.

In May 1972 Arthur Maslansky was retained by publicly traded First Leisure Corporation, a motion picture distributor, to act as special outside counsel to handle acquisitions and securities matters. He was employed by Steven Powers, president of FLC, and one of his first duties was the restructuring and closing of the acquisition of Goldstein Samuelson, Inc. GSI was engaged in the commodity option business and was wholly owned by Harold Goldstein. Prior to May 1972 Maslansky had no relationship with any of the parties.

From May 1972 until the beginning of November 1972 Maslansky represented the company in various corporate and securities matters interrelating primarily with the company's house counsel. During this period of time he had limited contact with Goldstein. His services culminated in his representation of the company and its principals in an SEC investigation which started at the end of September 1972 when trading in FLC stock was stopped by the SEC. By this time the company's only activity was its commodity option business.

Steven Powers resigned as president of FLC in the middle of October 1972 and Goldstein served as acting president.

Because of its concern for financial safeguards to protect investors in the rapidly growing commodity option business, the SEC requested Maslansky, while he was still outside counsel, to be a required signatory on all company checks in excess of \$10,000.

After negotiating a favorable consent decree on behalf of the company, Maslansky was approached by Goldstein concerning Maslansky becoming president of the company. After much discussion, Maslansky agreed to give up his law practice in consideration for a 5 year employment contract totalling \$750,000 base compensation. In the absence of Maslansky, the company's Board of Directors unanimously approved the agreement and Maslansky became president on November 3, 1972.

In late November 1972, Goldstein rescinded the acquisition of GSI by FLC resulting in GSI becoming a private company solely owned by Goldstein. Maslansky, as a condition of the rescission, required GSI to protect the bona fide public investors of FLC by offering to compensate them for their stock investment.

As president, Maslansky attracted highly qualified people to help run the company and endeavored to establish financial controls and fiscal responsibility. Under his direction substantial overhead and liabilities created by Goldstein prior to Maslansky becoming president were reduced. It was only because of the new personnel and the financial safeguards that Goldstein's attempted diversions of funds were discovered.

Maslansky went to Europe in January 1973 to develop an international commodity business. Upon his return in February 1973 he discovered that Goldstein was trying to circumvent the financial safeguards by attempting to divert over \$1,000,000 of customer funds. Maslansky halted the attempted diversions and immediately reported them to the SEC and the California Commissioner of Corporations. Maslansky then joined with the SEC on February 27, 1973 in moving for and obtaining the appointment of a temporary equity receiver to conserve the assets of the company for the benefit of the public. As a result of his prompt action, approximately \$8,000,000 was placed at the disposal of the receiver. Without Maslansky's cooperation and assistance, this would have been difficult to accomplish.

Since March 1973 Maslansky has been engaged in the private practice of law devoted to general corporate business with emphasis on commodity laws, taxes, securities, international finance and banking.

Robert Price has requested that his name be withdrawn from consideration as a candidate for the one year term on the Commodity Futures Trading Commission. It is therefore necessary to select a replacement.

You should be aware that while the other nominees to the Commission were undergoing clearance, their identity became generally known in the commodities industry and provoked some grumbling that they did not include individuals with sufficient "hands-on" commodities exchange experience. While this criticism is not very well founded, we have heard it from a number of industry sources. It therefore seems desirable to select as the new nominee someone who has recognized expertise in this area, first because doing so will help mute industry criticism, and second because someone with that background could in fact be helpful on the Commission.

The following candidates are suggested for your consideration:

Forest W. Reece, Jr., 33, Republican, of Texas (resume at Tab A), has been since 1971 a staff member on the Senate Agriculture and Forestry Committee, and was formerly Administrative Assistant to Bob Price. His qualifications are limited to the minimal knowledge gained on this Committee's staff, as most of the work on the legislation was done in the House. He has received nominal support from all the Republican members of the Senate and House Agricultural committees, and active support from Senator Curtis. His appointment would do nothing to counteract criticism of the lack of expertise represented on the Commission, and our impression is that he would not be a strong candidate.

Robert L. Martin, 60 Republican, of Illinois (resume at Tab B), is Vice President of Cook Grain Company, and a former Chairman of the Chairman Board of Trade. He has spent five years as a futures commission merchant and 34 years in the grain business. He was not associated with Cook during the Russian grain deal of 1972. Martin would be a distinguished appointment and would bring expertise to the Commission. He is supported by the grain trading industry, the futures commission merchants, and the exchanges, who have all complained about the lack of this type of substantive background on the Commission.

Houston A. Cox, Jr., 56, Republican, of New York (resume at Tab C), is Vice President for Commodities, Reynolds Securities, Inc. He has over 24 years of experience as a futures commission merchant, with special expertise in the international agricultural commodities and in metals. This type of background would be useful to the Commission since it is charged with bringing under regulation, for the first time, all the international agricultural and metal commodities. He is less attractive than Martin since he overlaps a bit Gary Seevers' agricultural expertise.

Peter A. Thatcher, 34, Republican, of Pennsylvania (resume at Tab D), is Vice President and Manager of the Commodity Finance Division, the Girard Trust Bank. He previously set up a commodity trading division for Merrill Lynch in the New England region, and was with Continental Grain for five years. He is particularly expert in the metals trading area.

Shirley R. Chilton, 51, Republican, of California (resume at Tab E), is Chairman of Daniel Reeves & Company, a small brokerage firm. In her twenty years in the brokerage business she has been actively engaged in managing brokerage compliance with CEA regulations. She has developed substantial expertise in gold and money markets. She was recommended in our earlier memorandum to you, but in light of subsequent criticism, is not as attractive a candidate, though she is qualified.
