A MORE CAREFUL SEARCH OF NSC AND STATE DEPARTMENT FILES HAS PRODUCED AN ADDITIONAL DOCUMENT.....

..... THIS DOCUMENT HAS BEEN REVIEWED BY THE ATTORNEY GENERAL WHO ADVISES THAT IT IS A PROPER ONE FOR ASSERTION OF EXECUTIVE PRIVILEGE.

STATE DEPARTMENT, NSC, PHIL BUCHEN AND I RECOMMEND THAT YOU INCLUDE THIS DOCUMENT UNDER YOUR CLAIM OF EXECUTIVE PRIVILEGE.

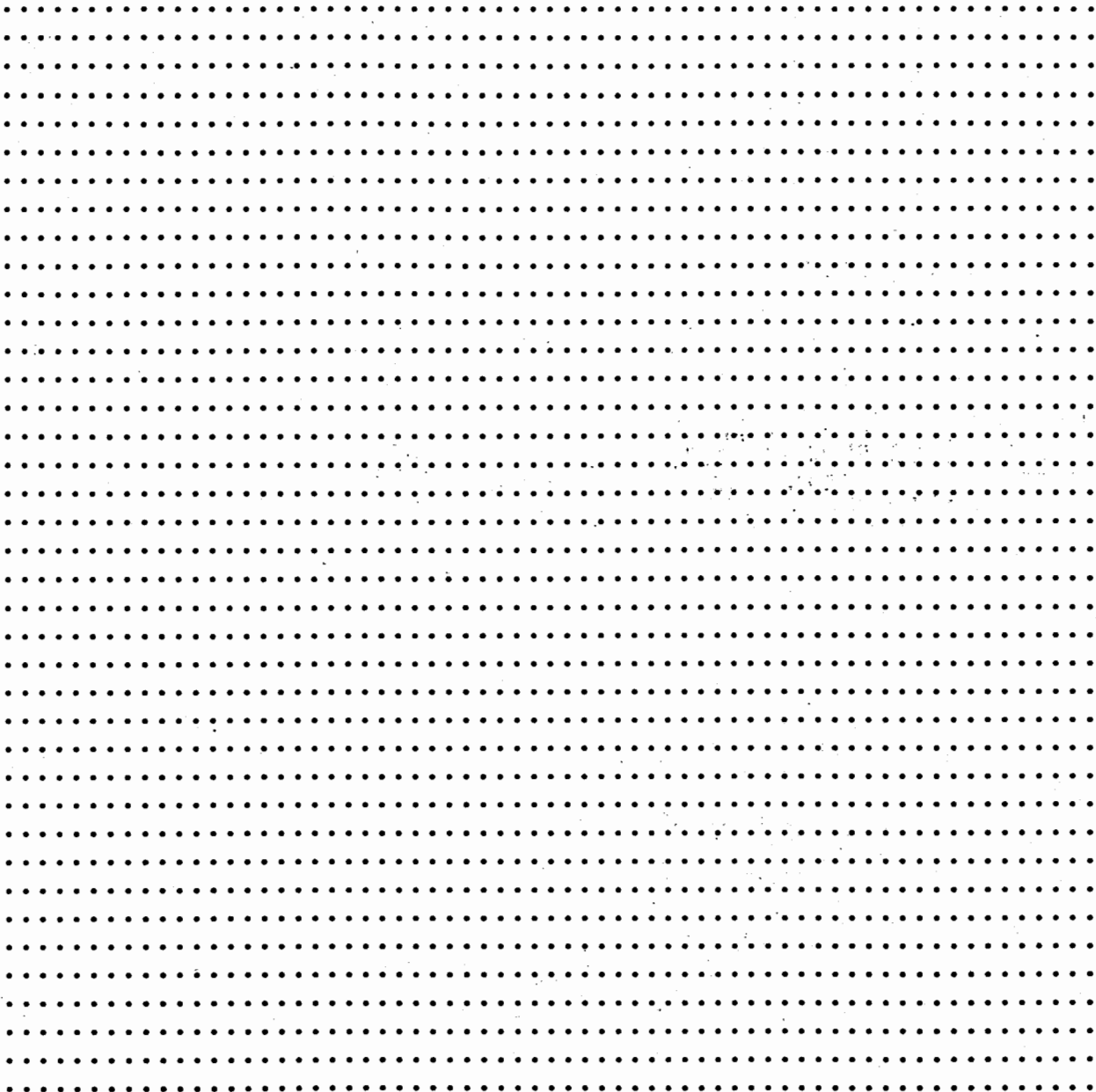
