Annual Prayer Breakfast for Life. Each year on January 22, prominent clergy, Congressmen and laypeople of many faiths gather in Washington, D.C. to give public witness to a deep and abiding faith that human life is a gift from God and is sacred and inviolate. The life-giving message of the Scriptures is proclaimed and the guidance of the Almighty is sought for the work that lies ahead. Your participation helps make the Prayer Breakfast a success each year. The 1975 Prayer Breakfast for Life tape cassette and accompanying study booklet are available for use by church and synagogue study groups as well as by pro-life organizations.

Organizational Development Teams. ACCL organizing teams have helped form new action groups in several states. They are available to assist new and established pro-life organizations in improving their structure, implementing fund raising ideas and developing education programs. Experienced people are ready to help whether the need is for initial building, or improvement of already existing organizations.

The ACCL Lobby. The ACCL Lobby encourages the enactment of an amendment to the United States Constitution that will make possible legal protection for unborn infants. This citizen action group works to improve the supportive services available to women with pregnancy problems, and recognizes the needs of women everywhere in nurturing their children. Specific concerns of this program include parenting, family life, health care for pregnant women and their children, nutrition, adoption and foster care, birth insurance, counseling, and support for families with children who have special needs. In addition, the ACCL Lobby is involved in bioethical issues such as human experimentation, organ transplantation, euthanasia, informed consent, and health care delivery. Progress in medical science is supported while upholding the rights of the individual. Meeting the needs of the mentally retarded, the aged and the handicapped is also a concern for the ACCL Lobby.

### HOW YOU, AS A PRO-LIFE CITIZEN, CAN BECOME PERSONALLY EFFECTIVE IN THE 1974 ELECTIONS

Grass roots political effectiveness is the single most essential factor in any plan to amend the United States Constitution. The pro-life community has its first opportunity to lay part of the groundwork for a human life amendment in November, 1974. In order to pass such an amendment, we need pro-life people in our law-making bodies. Following are some suggestions to help you personally effect the outcome of elections in your area.

- 1. You and each eligible member of your family must register and vote.
- You must also passionately encourage neighbors, friends, relatives, club and committee members - anyone who does or should agree with you - to register and vote.
- Get an evaluation of candidates from your area by contacting your local or state pro-life organization. Find out which candidates to support and recommend to others.
- 4. You must understand, and be able to explain to others, that the right to life is so fundamental to our political process that it justifies indeed, that it demands - that you evaluate candidates on this issue alone.
- 5. You should seek good counsel from state or local pro-life leaders as to whether it is wise to push one of several candidates as the pro-life candidate.
- 6. If there is any doubt at this late date, you can work with your local or state pro-life group to clarify the candidates' stands on pro-life issues by direct questioning of the candidates themselves, or of their campaign managers. Get solid answers. Don't settle for vagueries.
- 7. Ask your club, neighborhood or church groups, or your public library, to provide a forum in which the candidates can meet a significant sampling of their constituents or discuss their positions on issues. Offer to help with the arrangements.
- 8. Do whatever you can to show the pro-life candidates and their position to advantage, and the pro-abortion or neutral candidates and their position to disadvantage in letters to the editor, in questions to the candidates at public meetings, and so forth.
- 9. Be alert for announcements of meetings and debates in the media, and pass such information on to every available voter. Also, watch the letters-to-the-editor, and editorials in your local papers which can provide an opportunity for gaining valuable exposure for your candidate through a well-written response.

- 10. Filp make all citizens of your area sensitive to pro-life issues and the need for a human life amendment by bringing the subject up for discussion in letters to the editor, in conversations with friends, your minister, and your doctor. Have the topic placed on the agendas of community clubs, church groups, and any other civic organizations to which you or your friends have access.
- 11. Go to the campaign headquarters of a pro-life candidate and volunteer to stuff envelopes, make telephone calls, or do other needed chores.
- 12. Learn the name of your precinct chairman, or local political party leader from the election commission, your party headquarters, or your local newspaper. Approach him or her by phone or in person, and explain that you are interested in working for the success of pro-life candidates, and that you would like to personally volunteer wherever needed to help such candidates.
- 13. Offer to recruit your friends and club or church contacts to work, or offer to take work home to your family, friends or club.
- 14. Offer to host a spaghetti dinner or cocktail party as a fundraiser, or to recruit teenagers to wash cars. All candidates need fundraisers, so use your imagination.
- 15. Be willing to knock on doors and distribute information pamphlets.
- 16. Offer to organize a telephone campaign covering every house in your area.
- Offer to distribute bumper stickers in your club, or in your church parking lot.
- 18. Telephone everyone in your church or club who is likely to be pro-life, and remind each one to register to vote. You might also inform them of your interest in the success of pro-life candidates at the polls, and of the positions the various candidates take on pro-life issues.
- 19. Seek out voters who need absentee ballots, or who need assistance in getting to the polls on election day, and provide for their needs.
- 20. Help get out the vote on election day by providing or organizing transportation to the polls, by providing a child care facility, or by arranging for election-day public address announcements in local stores, shopping centers, and places of work. You may even intensively telephone on the eve of the election.

These suggestions will bear many different types of fruit. There will be the immediate result of greatly improving your candidate's chances in the election, of course. Also, by your presence and activity, you will become a vital part of your party's campaign, and your views will take on increasing significance. Your candidate will get to know you personally, and will value

your suggestions and opinions much more highly. The party leaders will also recognize the service you have done in bringing new recruits to the team, and although they may not agree with your stand entirely, they cannot ignore your contribution to their success.

For these reasons, it is vital to stay with the system. DON'T DISAPPEAR BETWEEN ELECTIONS! The best way to make yourself influencial is to make yourself indispensable. Learn the party system, and get acquainted with the leaders. Let people know why you and your friends are around, and that you intend to work indefatiguably for those ends. Party leaders have much greater respect for those who show consistent dedication than for people who show up every two years carrying a club.

One vital thing to remember is that you are going to make an impact whether your candidate wins or loses. You and your fellow workers will have had the opportunity to educate many previously untouched people. You will have laid the foundation for future pro-life working teams and cooperative efforts. You will have proven to party regulars that pro-life support is worth having. You will have made an impression that may cause even your opposition to re-think its position.

One final thought, and perhaps the most fundamental, is that all of these tips are 100% useless unless YOU put them into action. To be personally effective, you must take the lead and make things happen. You can't wait for someone to call you, knock on your door, or arrange a forum at which you can get your information. When you step in and assume the leadership role you will begin to direct the course of history.

#### ACCL TELEX SYSTEMS

Background for the ACCL Telex Systems: Before the ACCL Telex Systems, all prolife national alerts depended on mailing, publishing or "telephone chains". All three systems are cumbersome, expensive, and relatively slow compared to the ACCL telex system. Mailed communications may take three to four days to arrive; published information may be updated only every three or four weeks; telephone trees tend to be inaccurate and to break down. Communications between large area or state groups are similarly inconvenient and haphazard.

Purpose of the ACCL Telex Systems: To establish almost instant communication between large area or state groups, and to enable national alerts to penetrate well down into prolife ranks in less than 24 hours, with no loss in accuracy.

Information about the ACCL Telex Systems:

- -- they use Telex-Westem Union hookups from the ACCL offices.
- -- every individual or group of individuals who have an accumulated total of ten ACCL "shares" (\$100.00 worth) are placed on the ACCL overnight mail-gram alert system as a complimentary service.
- -- every large area or state group whose members have bought five hundred ACCL "shares" (\$5000.00 worth) can have a telex machine installed in their office at ACCL's expense, and they will receive a complimentary communication service from ACCL. They may use the machine for their own internal communication functions, to communicate with other state groups and are responsible for all monthly and usage charges.

Background: There are many different philosophies on how to win a Constitutional amendment. These cause confusion and ineffectiveness in the national prolife movement.

Purpose of the ACCL "Pyramid Plan" of Leadership Development: To develop uniform, consistent, high quality national prolife leadership committed to a widely accepted plan and methodology.

#### Preliminary notes on the Plan:

- -- There probably always will be different ideas about how to enact a Constitutional Amendment; however, the whole movement will benefit from the participation of many leaders in a disciplined plan development project, and organized preparation and training to make that plan work.
- -- The "curriculum" will involve both "theoretics" (what we are trying to do and why we do them our way) and "practics" (how we do things).
- -- The "curriculum" will include borrowing from the discipline of Organization Development (Beckhard, Bennis and others), and from Community Organization (Alinsby and others); from the experience of some of the best prolife state groups; from the original analysis and planning of many excellent Washington, D.C. sources, and from the comments and criticisms of the ACCL Advisory Committee, et cetera.
- -- The "curriculum" will be taught by correspondence with "students", and by a series of graduated training sessions (hence the name "Pyramid Plan").
- -- "Students" will participate in the preparation of the "curriculum" at the same time as they are learning, and thus will be able to leave something of themselves in the course to benefit those who follow.



- -- The "curriculum" will be compatible with the ACCL Comprehensive "Overall Plan", the ACCL "Axioms of Effective Political Action" and the ACCL "Specifications for an Ultimate State Prolife Organization" which are being designed by the ACCL Board with the advice of its Advisory Committee.
  - -- the "Overall Plan" sets out the conditions which, in our opinion, must be met by the prolife movement before a Constitutional Amendment will be passed by Congress and ratified.
  - -- the "Axioms" of political action delineate the most effective ways the prolife movement can work in the public sphere.
  - -- the "Specifications" set out the characteristics of state organizations which are able to succeed in their legislatures, hold their own with the media, and gain the support of the public in their states.
