
Discussion

Existing law (20 U.S.C. 42) provides that the Board of Regents of the Smithsonian Institution be composed of the Vice President, the Chief of Justice of the United States, three Members of the Senate, three Members of the House of Representatives, and nine other persons, other than Members of Congress. The nine citizen regents are to be appointed by joint resolution of Congress for six-year terms.



Pursuant to that law, the Board of Regents voted unanimously to request Congressional members of the Board to introduce legislation to provide for the reappointments of Drs. William A.M. Burden and Caryl P. Haskins and the appointment of Dr. Murray Gell-Mann to a position vacated by Dr. Crawford H. Greenewalt on May 30, 1974.

These enrolled joint resolutions carry out the Board of Regents recommendations. The biographies of the three citizen regents concerned are set forth in the Committee reports.


The manner of appointment and terms of office of Regents of the class other than members of Congress are set forth in 20 U. S. C. 43. At its meeting on May 14, 1974, the Board of Regents voted unanimously to request the Congressional members of the Board to introduce legislation to provide for the statutory six-year-term appointment of Dr. Gell-Mann to the vacancy occurring on the Board on May 30, 1974, because of the expiration of the term of Dr. Crawford H. Greenewalt of Wilmington, Delaware. Dr. Greenewalt chose not to stand for reappointment.

Dr. Gell-Mann is a distinguished theoretical physicist who received the Nobel prize in physics in 1969. He has been an active member of the Smithsonian Council and, as a resident of California, will bring to the Board broader geographic representation. A biography of Dr. Gell-Mann is enclosed.

There are no initial or recurring costs or savings to the Government under this measure.

The Smithsonian Institution respectfully recommends endorsement by the President of S. J. Res. 222.

Mr. NEDZI, from the Committee on House Administration,
submitted the following

REPORT

[To accompany S.J. Res. 222]

The Committee on House Administration, to whom was referred the joint resolution (S.J. Res. 222), having considered the same, report favorably thereon without amendment and recommend that the joint resolution do pass.

By unanimous consent the Committee adopted a motion to report Senate Joint Resolution 222.

Senate Joint Resolution 222 would provide that Dr. Murray Gell-Mann, a resident of California, be appointed to the Board of Regents of the Smithsonian Institution of the class other than Members of Congress. This appointment would be for the statutory term of 6 years. The Senate approved the joint resolution on July 15, 1974.

Dr. Gell-Mann is a theoretical physicist and a professor at the California Institute of Technology. He was awarded the Nobel Prize in physics in 1969.

Pursuant to 20 U.S.C. 42, the Board of Regents is composed of the Vice President, the Chief Justice of the United States, three Members of the Senate appointed by the President of the Senate, three Members of the House of Representatives appointed by the Speaker, and nine other persons other than Members of Congress. The nine Citizen Regents, two of whom shall be residents of the District of Columbia and seven of whom shall be residents of some State (but no two shall be residents of the same State) are appointed by joint resolution of Congress to serve 6-year terms.

A report in further clarification of Senate Joint Resolution 222 addressed to Hon. Wayne L. Hays, Chairman of the Committee on House Administration, by S. Dillon Ripley, Secretary of the Smithsonian Institution, is as follows:

DEAR MR. CHAIRMAN: I would like to take this opportunity to comment on H.J. Res. 1074 to provide for the appointment of Dr. Murray Gell-Mann as citizen regent of the Board of Regents of the Smithsonian Institution.

The manner of appointment and terms of office of Regents of the class other than members of Congress are set forth in 20 U.S.C. 43.
