MEMORANDUM FOR THE SECRETARY OF DEFENSE

SUBJECT: Analysis of House Voting Records

- Tab A: Individual Voting Records
 Tab B: Groupings (Firm, Swing, Loss)

Attached are various breakdowns of the voting records of the Members of the House of Representatives during the Second Session of the 93d Congress. Included in Tab A are three votes on MASF, two votes on overall budget reductions, and one vote each on the B-1 Bomber, Diego Garcia and overseas troop reductions. Also included, for information purposes, are the two votes on Strategic Initiatives which were not included in the development of the voting groups. As you will note, the categories relate to defense issues in general, are weighted heavily on the two major issues of this session, and can vary considerably depending upon the specific issue.


Using the eight indicator votes, the House can be generally categorized as follows:

<u>Category</u>	<u>Republicans</u>	<u>Democrats</u>	<u>Total *</u>
Firm	134	75	209
Swing	42	53	95
Loss	12	118	130

*Speaker Albert does not vote.

We have further refined the Swing Category into those who lean towards or away from general support of defense issues. The Sub-Groups are as follows:

Tab B also high-lights those 45 Members who we know, as of this date, will not be returning to the Congress next year. The breakdown of that group is as follows:

Tab A is organized to provide a ready-reference on the two major issues of this session, MASF and across-the-board reductions. An analysis of the MASF votes fails to reveal any significant cause for the adoption of the Flynt amendment. The debate on the Floor consisted of all the same arguments on both sides with the following additional points: (1) that the House had adopted the \$1 billion figure only one week before the Appropriation Bill, (2) that the situation in Vietnam was becoming more grave, (3) that the ARVN had been forced to substitute human casualties for firepower tactics as a result of previous funding reductions, and, in opposition to the Defense position, (4) that the Thieu regime was using the war to prevent a political settlement and (5) that the Defense Department had not even expended the funds available to it last year. In this latter argument, the opponents conveniently overlooked the difference between unexpended and unobligated balances. This "oversight" must be considered intentional since the opponents were senior members of the House Appropriations Committee who must know the difference.

On Aspin/Addabbo amendments, many of the fiscal conservatives who voted with Aspin voted against Addabbo. Perhaps the argument that this type of fiscal management was irresponsible and provided too much authority to the Executive Branch was the prime cause for the defeat of the Addabbo amendment -- especially in the current political environment.
