

DEAR MISS MATSON,

AS I MENTIONED TO YOU ON THE PHONE LAST WEEK, CHILDREN'S HOSPITAL CONDUCTED THEIR FIRST "CAROLING FOR CHILDREN'S" PROGRAM THROUGHOUT THE CITY AND SUBURBS OF WASHINGTON LAST YEAR. AGAIN THIS YEAR, WE ARE ORGANIZING THE PROGRAM, AND WE HOPE IT WILL BECOME AN IMPORTANT AND MEANINGFUL TRADITION IN WASHINGTON OVER THE YEARS AHEAD - ONE WHICH WILL BUILD GOODWILL FOR CHILDREN'S HOSPITAL AND ALSO FOCUS THE WASHINGTON COMMUNITY ON CHILDREN, FAMILIES AND NEIGHBORHOODS, OUR CONSTANT CONCERN AT THE HOSPITAL.

THE MAIN THRUST OF THE PROGRAM IS TO ENCOURAGE FAMILIES TO GET TOGETHER WITHIN THEIR NEIGHBORHOODS AND GO CAROLING SOMETIME DURING THE WEEK PRECEDING CHRISTMAS. ALTHOUGH THESE GROUPS DO ACCEPT CONTRIBUTIONS AS THEY GO FROM DOOR TO DOOR, THIS IS NOT THE PURPOSE OF THE PROGRAM SO MUCH AS THE BUILDING OF GOODWILL AS I HAVE JUST MENTIONED. "CAROLING FOR CHILDREN'S" IN THE DISTRICT IS BEING ORGANIZED IN THE PUBLIC SCHOOLS BY THE DISTRICT OF COLUMBIA PARENT TEACHERS ASSOCIATION. THERE WILL BE A GREAT DEAL OF PUBLICITY GIVEN THE PROGRAM OVER THE LOCAL RADIO AND TELEVISION STATIONS. WE ALSO WILL HAVE A NUMBER OF SPECIAL SINGING GROUPS CAROLING IN HOTEL LOBBIES AND SHOPPING CENTERS AS WE DID LAST YEAR. I AM ENCLOSING SOME OF THE MATERIAL THAT GOES OUT IN OUR CAROLING KIT FOR YOUR INFORMATION.

IT WOULD BE A TREMENDOUS BOOST TO THE "CAROLING FOR CHILDREN'S" PROGRAM IF PRESIDENT AND MRS. FORD AND THEIR CHILDREN WOULD ALLOW A GROUP REPRESENTING CHILDREN'S HOSPITAL TO CAROL TO THEM FROM THE WHITE HOUSE LAWN SOMETIME DURING DECEMBER. THE GROUP WOULD BE FORMED FROM THE MEMBERS OF THE "CAROLING FOR CHILDREN'S" COMMITTEE AND THEIR FAMILIES. MANY OF THE COMMITTEE MEMBERS ARE CONNECTED WITH CHILDREN'S

CAROLING FOR CHILDREN'S

WHAT IS IT?

"Caroling for Children's", is an annual project sponsored by Children's Hospital National Medical Center, a non profit organization incorporated under the laws of the District of Columbia. During Christmas week, a network of carolers sweeping through many metropolitan areas will deliver the Christmas message in song while asking for voluntary contributions to Children's Hospital. Additionally throughout the month of December, carolers will tour neighboring hotels, motels, restaurants and shopping areas.

WHAT IS THE PURPOSE?

The project is designed to serve two purposes:

1. To preserve the custom of caroling as a demonstration of thankfulness for Christmas.
2. To provide needed funds for Children's Hospital.

HOW ARE CAROLERS RECRUITED?

Carolers will be recruited from local churches, schools, musical clubs and residential developments. Anyone wishing to help can organize a group of 10 singers, then call "Caroling for Children's" at 835-4387. Children under 16 must be accompanied by an adult.

HOW DO CAROLERS RAISE FUNDS?

"Caroling for Children's" is authorized by the Board of Directors of Children's Hospital to accept contributions at each site visited by the carolers. Each group will carry sealed canisters into which donations may be placed.

HOW ARE THE CAROLERS IDENTIFIED?

Each red and white canister will bear the seal "Caroling for Children's". In addition, group leaders will be issued identifying Solicitor's Information cards.

WHY IS THERE A NEED FOR CHILDREN'S HOSPITAL?

For over 100 years Children's Hospital has provided the best care available to sick children from birth to adolescence. Last year over 130,000 patients were treated in a crowded building which is over 75 years old. The new hospital now being constructed on the grounds of the Washington Hospital Center, will bring together all related child health programs and assure comprehensive pediatric services using the most modern technical facilities. It will combine in-patient and out-patient services, education, training and research to provide regional and national leadership in all aspects of child health and development. Because of Children's open door policy to care for all children regardless of their ability to pay, the need for funds for the Hospital is ever present.





MICHAEL CARNEYMAESTRO WITH A MISSION

To the average reader of the headier gossip columns and the slicker society magazines, the world of exotic costume parties, debutante balls and extravagant wedding receptions are fantasy which bring respite from the humdrum and work-a-day world. For Michael Carney, young, good-looking pianist-orchestra leader, his working world is the very real ultra-glamour dancing circuit of New York, Los Angeles, Palm Beach and points in between.

With every recent decade and its changing musical forces, it seems, one orchestra became identified with that period. In only a few short years, Mike Carney has made his name a household word among the nation's elite and his is certainly the name for the 70's.

Most recently, Mike Carney set the pace for two of the most brilliant debutante parties of this season--that of Laurie Hawk, the glamorous daughter of Mrs. Thomas P. F. Milbank and the dinner dance given by Mrs. John T. Pratt for her granddaughter, Libby Hamilton.

His music first came to national attention when he played at the celebrated "Night in Bombay" party given by Donald and Fernanda Leas in Southampton in 1966. Since then his credits read like a virtual roll call for every important party and party-giver extant. They include the Boys Club of New York dinner dances and the Grosvenor Ball in New York; the Autumn Ball in Tuxedo Park, N. Y.; The Swan Ball in Nashville; the Preservation Society Ball in Newport; the Maryland Hunt Cup Ball in Baltimore; the Bachelors Ball in Los Angeles; and The Coconuts party in Palm Beach. Some of the private clubs he has performed for are

Club El Morocco and Raffles in New York; The Meadow Club in Southampton; The Maidstone Club in Easthampton; The Jupiter Island Club in Hobe Sound, Fla.; Myopia Hunt Club in Boston; Country Club of Detroit in Grosse Pointe, Mich.; Onwentsia Club in Lake Forest, Ill.; Rolling Rock Club in Ligonier, Pa.; and the Brook Hollow Golf Club in Dallas.

Mike describes his music this way: "It's not basically different from the competition but every minute of music, whether fast or medium tempo, must have a distinctive 'bite' that really goads everyone into moving rhythmically." He feels the most important factor in achieving this "bite" is a leader who is a rhythm instrumentalist (piano or guitar) and who plays with such strength at all times that the rest of the orchestra "plays up" to his lead and therefore achieves a continuous excitement. Naturally the other musicians must be top rate talents and Mike has spent the last 8 years cultivating a small core of the best musicians in New York, Philadelphia and Florida. Many listeners associate Mike with his whistling which he believes adds to the rhythm and musical effect. Also, he has recently added singing to the lineup. However, it is his piano talent that is the real secret of his popularity.

The bulk of Mike Carney's repertoire does not consist of an evening down memory lane with the alarmingly familiar show tunes which are the standards of most society orchestras. His list of fox trot or two step numbers includes many obscure songs from all eras and facets of the music business. Several Bobby Short, Mabel Mercer, Matt Dennis and Noel Coward specialties are featured along with the best (though not best-known) of Cole Porter, Richard Rodgers, Cy Coleman and Jules Styne. The Bossa Nova is a type of music and dance that few competitors play as frequently as Mike. Most of the Bert Bacharach and Sergio Mendes music

must be played in this style to be effective and it is something of a transition rhythm between two step and rock.

On the rock numbers, Mike does his own singing and uses all the members of the orchestra (except when his separate rock band "The Hard Knox" are booked as an alternate group). He reacts strongly against the one long haired guitarist-singer employed by most orchestras because it usually covers up for a lack of preparation on the rock numbers by the full group. The rock beat becomes a true test of the society orchestra's rhythm section and Mike insists on a bite that comes very close to that of his fantastic "Hard Knox."

In his early thirties, Mike Carney leads an active social life between engagements. As one of New York's most eligible bachelors, he is seen frequently at dinner parties and night spots and finds time to engage in his favorite sports--tennis and paddle tennis.

He grew up in Irvington, New York, a Westchester suburb, and first started playing professionally at the age of 14 by forming a 7-piece dance band. As an undergraduate at Northwestern University he formed another group which played for fraternity and school parties. He met his current partners, Gerry Romig and Rick Lewis, while still in college and the three men played on a part time basis in the Philadelphia area while each pursued business careers. After the "Night in Bombay" party which brought him to national attention, Mike moved to New York where he now oversees his nation-wide operations.

People who have the ability and love to dance can quickly tell the difference between merely good and superior dance music. These are the



critics who have been responsible for Mike Carney's success. He takes his mission seriously, "To make people really enjoy dancing," and is currently preparing for an LP album which will be available early in 1973.

The President and Mrs. Ford will host a Christmas Ball for members of Congress on Tuesday, Dec. 17 at 9 p.m. It is black tie and will be held on the State Floor of the White House.

About 900 guests are expected. Included in the guest list are members of the House of Representatives and the Senate, Cabinet members, senior White House staff and congressional liaison aides at the White House.

Entertainment will be by New York pianist-orchestra leader Mike Carney, who will provide music for dancing in the East Room. A light buffet will be served in the State Dining Room and the Marine Dance Combo will provide music in the Grand Hall.

Table coverings will utilize the overall quilt-hand craft theme of the White House Christmas decor this year. Tables will be draped with red cloths topped with patchwork fabric which has been given to the White House by Papiers Peints, a fabric shop in New York. The material is a specially screened cloth in a red and green pattern called "Friendship Train and Clover."

Floral arrangements will be in 3-foot high gold genie baskets and will consist of red carnations and holly, oregon cedar and incense cedar. Arrangements on the cabaret tables in the dancing area will consist of hurricane lamps surrounded by mixed greens and holly.

There are three creche figures at the base of the Christmas tree in the Blue Room of the White House. The two angels are from Mexico and believed to be from the 18th century. They are on loan to the White House from the Metropolitan Museum of Art, a gift of Mrs. Loretta Hines Howard of New York City in 1964. The figure of the infant is French and of the 18th Century. It is on loan from Mrs. Loretta Hines Howard.


