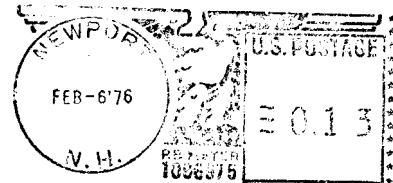



Reagan's little helper

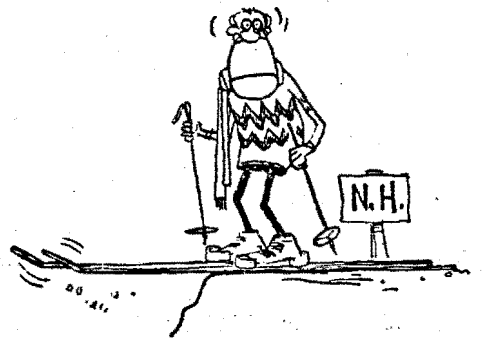

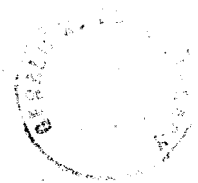
So on Monday, the White House had to trot out another aide to say that, goodness gracious, the President has always said how much he loves New Hampshire snow.
