For an additional amount for "Compensation of Members", \$787,200.

For an additional amount for "Compensation of Members", for the period July 1, 1976 through September 30, 1976, \$262,400.

Joint Committee on Internal Revenue Taxation

For an additional amount for "Salaries and expenses of the Joint Committee on Internal Revenue Taxation", \$75,000.

For an additional amount for "Salaries and expenses of the Joint Committee on Internal Revenue Taxation" for the period July 1, 1976, through September 30, 1976, \$18,800.

These supplemental requests include \$787,200 for 1976 and \$262,400 for the transition quarter for Compensation of Members to cover the increased cost of the October and 1976 Federal pay raise.
