REF: POPPLE OCTOBER 25 LETTER TO GLEYSTEN

1. WE AGREE THAT WHILE DIALOGUE IN TERMS SET BY PREMIER CHIANG'S INITIAL PRESENTATION WILL NOT BE VERY PRODUCTIVE, THERE IS OBLIGATION TO REPLY TO PREMIER.
2. TO OBVIATE NEED FOR YET ANOTHER DISCUSSION ON PREMIER'S PRESENTATION, WE SUGGEST YOUR PROPOSED TALKING POINTS BE PRESENTED AS DEPARTMENT'S VIEWS. WE WOULD APPRECIATE FOLLOWING REVISIONS IN TALKING POINTS WHICH OTHERWISE FINE:
3. PARA 4 -- REVISE TO READ, "PRESIDENT FORD, AS ONE OF HIS FIRST ACTS OF OFFICE, EMPHASIZED THE CONTINUITY OF US FOREIGN POLICY AND OUR INTENTION TO MAINTAIN EXISTING COMMITMENTS."
4. PARA 5 -- LIMIT YOURSELF TO THE GENERAL OBSERVATION THAT THE ADMINISTRATION FEELS THAT THE PRESENT FORM OF RELATIONSHIP WITH THE PRC IS SATISFACTORY.

1. AT 12 NOON, NOVEMBER 11 (1:00 A.M. TUESDAY, PEKING TIME) THE FOLLOWING ANNOUNCEMENT WILL BE ISSUED JOINTLY IN WASHINGTON AND PEKING: BEGIN TEXT IT HAS BEEN AGREED UPON THROUGH CONSULTATIONS THAT THE UNITED STATES SECRETARY OF STATE AND ASSISTANT TO THE PRESIDENT FOR NATIONAL SECURITY AFFAIRS, DR. HENRY A. KISSINGER, WILL VISIT THE PEOPLE'S REPUBLIC OF CHINA FROM NOVEMBER 25 TO NOVEMBER 29, 1974. END TEXT

2. YOU ARE INSTRUCTED TO INFORM PM CHIANG CHING-KUO AT 1:00 P.M. TAIPEI TIME NOVEMBER 11 OF THIS ANNOUNCEMENT, TELL HIM WE WANTED ROC TO BE INFORMED IN ADVANCE, AND ASK THAT STRICTEST SECRECY BE MAINTAINED UNTIL ANNOUNCEMENT IS MADE PUBLIC. YOU SHOULD ALSO EMPHASIZE TO HOST GOVERNMENT THAT "THIS VISIT IS IN ACCORDANCE WITH THE SHANGHAI COMMUNIQUE WHICH CALLED FOR PERIODIC HIGH LEVEL CONTACTS BETWEEN THE TWO GOVERNMENTS." KISSINGER

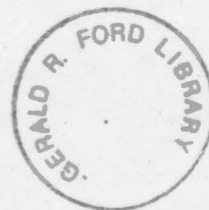

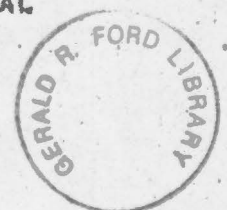
1. AMBASSADOR SHEN REQUESTED URGENT APPOINTMENT WITH
INGERSOLL TO SOUND US OUT ABOUT APPOINTMENT OF NEW ROC
AMBASSADOR, PRESUMABLY CHOW SHU-KAI.

2. WE PLAN TO TELL ROC THAT WHILE WE HAVE HIGHEST
REGARD FOR CHOW, WE HAVE REGRETFULLY CONCLUDED THAT
SWITCH IN AMBASSADORS AT PRESENT TIME WOULD BE
INAUVISABLE. WE WILL EXPLAIN THAT OUR VIEW STEMS FROM
CONCERN THAT SWITCH IN CURRENT CIRCUMSTANCES WOULD ADD
WEIGHT TO PUBLIC SPECULATION ABOUT A COOLING IN US-PRC
RELATIONS. TO SOFTEN IMPACT, WE WILL TELL ROC THAT IT
SHOULD NOT OVER INTERPRET OUR REACTION AS HAVING SPECIAL

SIGNIFICANCE IN TERMS OF US-PRC NORMALIZATION DEVELOPMENTS. OUR RECENT ASSENTION TO ROC THAT FORD VISIT WAS AGREED WITHOUT CONDITIONS REMAINS VALID. WE WILL ADDITIONALLY ASSURE ROC THAT MATTER WILL BE HELD IN TIGHTEST CONFIDENCE BY USG.

3. WE WOULD WELCOME YOUR VIEWS BY IMMEDIATE/NIACI AS TO WHETHER ABOVE PRESENTATION SHOULD BE MADE BY YOU TO CCK, WHICH WOULD HAVE ADVANTAGE OF SPARING AMBASSADOR SHEN SOME PERSONAL EMBARRASSMENT, TO BOTH SHEN AND CCK OR TO SHEN ALONE. OUR INSTINCT IS TO GO TO BOTH. KISSINGER

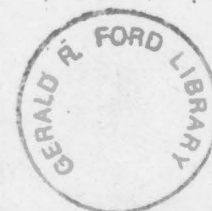

EYES ONLY AMBASSADOR, PURPLE AND FLINTCROFT

1. HAS UNCOVERED DISTURRING EVIDENCE OF ROC EFFORT
TO ACQUIRE MARK 37 TORPEDOES ILLEGALLY IN US. INFORMATION
DEVELOPED
REVEALS THAT NSB OPERATIVES HERE ARE SERIOUSLY NEGOTIATING
WITH PRIVATE ARMS DEALERS FOR PURCHASE OF TORPEDOES WHICH
THEY KNOW ARE TO BE STOLEN FROM US NAVY. AS INDICATION
OF ROC INTEREST IN SUBJECT, ROCN TORPEDO EXPERT MADE

IN ACT OF DESPERATION, WE DOUBT THAT HE IS FULLY AWARE OF THIS OPERATION WHICH INVOLVES SUCH EXTRAORDINARY RISKS AND GREAT POTENTIAL FOR SERIOUS DAMAGE TO US-ROC RELATIONSHIP. THERE HAVE BEEN PAST INSTANCES OF ROC INTELLIGENCE APPARATUS ACTING WILDLY ON OWN IN HOPE OF REAPING

INTELLIGENCE COUP AND GLORY. PRESENT CASE MAY FIT THAT PATTERN. ROC OPERATORS MAY ALSO HAVE BEEN ENTICED AND CONNED BY US SWINDLERS.

3. IN ANY EVENT, WE BELIEVE THERE IS SUFFICIENT EVIDENCE OF ROC INVOLVEMENT TO WARRANT OUR REACTING STRONGLY. WE ENVISAGE AMBASSADOR MAKING PRESENTATION TO CCK WHICH PROVIDES DETAILS OF ROC INVOLVEMENT, REQUESTS APPROPRIATE REMEDIES, AND WARNS THAT SUCH BEHAVIOR IS BOUND TO HAVE HIGHLY ADVERSE IMPACT ON OUR MILITARY SUPPLY RELATIONSHIP WITH ROC. WE WOULD ALSO TELL CCK THAT TO SPARE BOTH US AND ROC FROM EMBARRASSMENT NO PUBLIC DISCLOSURE WILL BE MADE.

4. WE ARE SENDING VERBATIM ACCOUNTS OF FBI REPORTING ON CASE BY SEPTELS. WE WOULD APPRECIATE YOUR URGENT EVALUATION AND COMMENTS ON THESE REPORTS AND ON OUR PROPOSED COURSE OF ACTION. KISSINGER
